ENFORCEMENT NOTICE

ISSUED BY: THE LONDON BOROUGH OF WALTHAM FOREST

1. **THIS NOTICE** is issued by the Council because it appears to them that there has been a breach of planning control, within paragraph (a) of Section 171A (1) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to all other material considerations. The Annex at the end of the notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THE NOTICE RELATES**

Land at 291 Chingford Road, London E17 5AB, registered under title number EGL498865 and shown edged black and hatched red on the attached plan.

3. **THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL**

Without planning permission, change of use of ground floor retail shop with ancillary accommodation to use for the purpose of two self-contained flats, the erection of a part single, part two storey extension and installation of new metal shutters.

4. **REASONS FOR ISSUING THIS NOTICE**

It appears to the Council that the above breach of planning control has occurred within the last four years.

The unauthorised conversion into two self-contained flats, the erection of the extensions and the installation of metal roller shutters to the garage is development and requires planning permission.

The part single, part two storey rear extension, by virtue of its overall size, bulk and materials is out of keeping with the local area and detrimental to the street scene. The development is contrary to policies SP1, SP2, BHE1 and PSCS5 of the adopted Waltham Forest Unitary Development Plan (UDP) 2006 and guidance in Supplementary Planning Guidance Note 1 (SPGN1) Residential Development

Design Standards and Supplementary Planning Guidance Note 4 (SPGN4) – House Extensions.

The part single, part two storey extension, by virtue of its overall size and bulk has a detrimental impact on the occupiers of the neighbouring properties, due to loss of outlook and general amenity, and is contrary to policies BHE3 and PSC5 of the adopted Waltham Forest UDP and guidance in SPGN 1 and SPGN 4.

The Council do not consider that planning permission should be given, because planning conditions could not overcome these objections to the development

5. WHAT YOU ARE REQUIRED TO DO

- (1) The cessation of use as 2 self-contained flats.
- (2) The removal of the part single, part two storey extension
- (3) The removal of the metal shutter
- (4) The removal of all materials from site and reinstatement to a tidy condition


6. TIME FOR COMPLIANCE

Six Months (6) after this notice takes effect.

7. WHEN THIS NOTICE TAKES EFFECT

This notice takes effect on 1 December 2006 unless an appeal is made against it beforehand.

YOUR RIGHT OF APPEAL

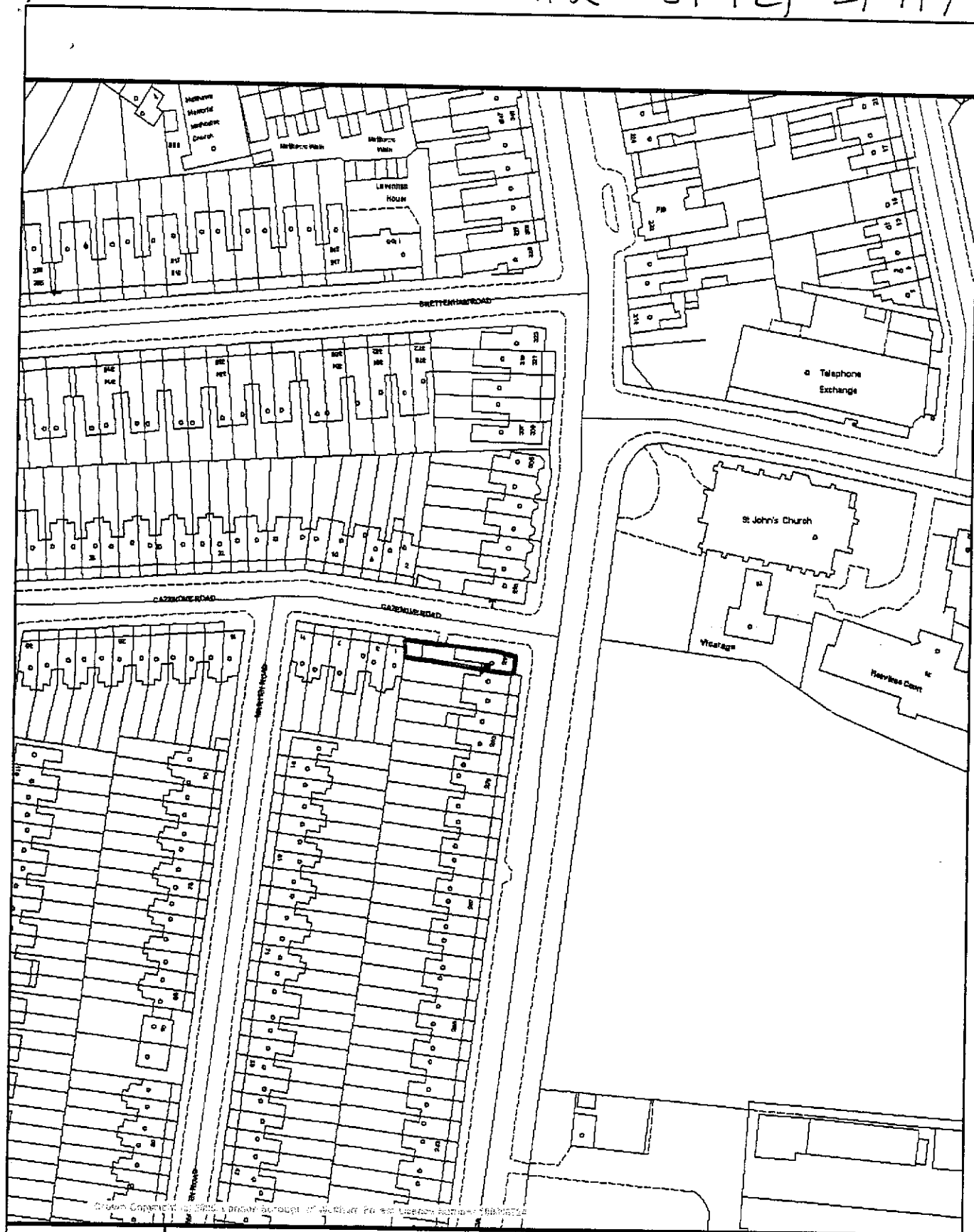
You can appeal against this notice, but any appeal must be received, or posted in time to be **received**, by the Secretary of State **before** the date specified in paragraph 7 of the notice. The enclosed booklet "Making your enforcement appeal" sets out your rights. Read it carefully. You may use the enclosed appeal forms.

- (a) One is for you to send to the Secretary of State if you decide to appeal together with a copy of this Enforcement Notice.
- (b) The second copy of the Appeal Form and the Notice should be sent to the Council.
- (c) The third copy is for your own records.

WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this Enforcement Notice, it will take effect on the date specified in paragraph 7 of the notice and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period[s] specified in paragraph 6 of the notice. Failure to comply with an enforcement notice which has taken effect can result in prosecution and/or remedial action by the Council.
