**ENFORCEMENT NOTICE**

ISSUED BY: LONDON BOROUGH OF WALTHAM FOREST

1. **THIS NOTICE** is issued by the Council because it appears to them that there has been a breach of planning control within paragraph (a) of Section 171A (1) of the above Act, at the land described below. They consider that it is expedient to issue this notice, having regard to the provisions of the development plan and to other material considerations. The Annex at the end of the Notice and the enclosures to which it refers contain important additional information.

2. **THE LAND TO WHICH THIS NOTICE RELATES**

Land at 7 Orford Road Walthamstow E17 registered at HM Land Registry under title number EX24416 and shown edged black and hatched red on the attached plan.

3. **THE MATTERS WHICH APPEAR TO CONSTITUTE THE BREACH OF PLANNING CONTROL**

Without planning permission, the installation of a satellite dish.

4. **REASONS FOR ISSUING THIS NOTICE**

It appears to the Council that the above breach of planning control has occurred within the last four years. The installation of the satellite dish in question occurred less than four years ago.

The satellite dish is considered to be an unnecessary and unsympathetic addition to the dwelling and is detriment to the character and appearance of the Conservation Area, contrary to policies BHE13 AND PSC9 of the adopted Waltham Forest Unitary Development Plan (2006).

The Council do not consider that planning permission should be given, because planning conditions could not overcome these objections to the development.

5. **WHAT YOU ARE REQUIRED TO DO**

- (1) Remove the satellite dish including all related equipment and make good any associated damage.


6. **TIME FOR COMPLIANCE:**

This notice takes effect on 10 November 2006 unless an appeal is made against it beforehand.

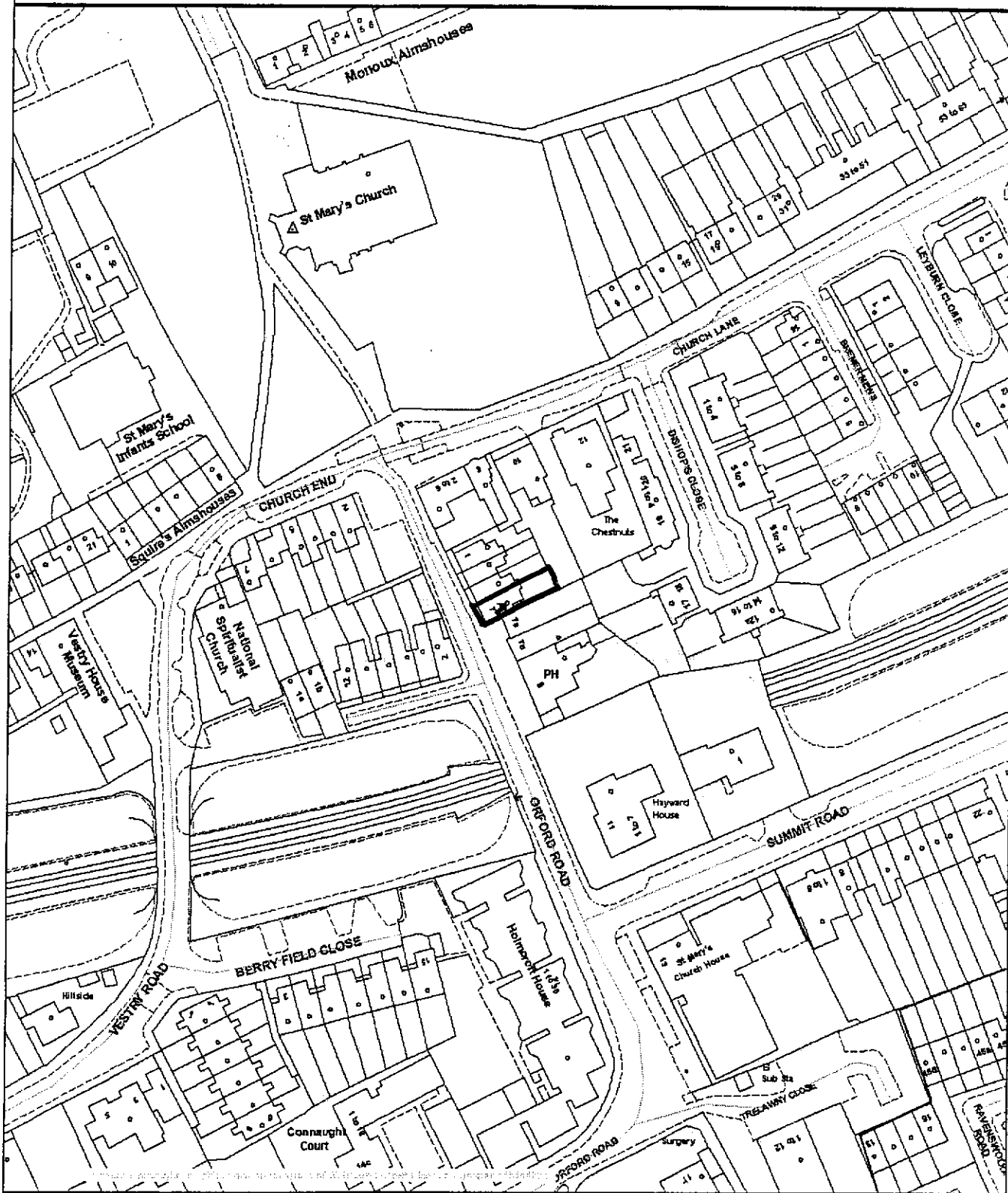
- (a) One is for you to send to the Secretary of State if you decide to appeal together with a copy of this Enforcement Notice

**WHAT HAPPENS IF YOU DO NOT APPEAL**

If you do not appeal against this Enforcement Notice, it will take effect on the date specified in paragraph 7 of the notice and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period[s] specified in paragraph 6 of the notice. Failure to comply with an enforcement notice which has taken effect can result in prosecution and/or remedial action by the Council.
