Page 28 - Chapter 2, Policy INB1	Policy statement - delete final paragraph beginning "Where appropriate.....Employment Areas"
Page 142 - Chapter 8, Policy BHE 7	Policy statement - Bullet point numbering of BHE7 should be A), B), ...G), instead of D), E)....J).
Page 169 - Chapter 10, Paragraph 10.12	'(140ft)' in the third sentence should be (140 sq. ft).

Page 19 - Fig 1.1	Leyton centre (coloured yellow) – This is a neighbourhood centre, not a district centre as shown.

Page 200 - Schedule 5, Sutherland Road (MURA3)	Description of land/properties - Add close bracket after "...32 St Andrews Road".

LEA2	Units 10-20 Ravenswood Industrial Estate is part of the designated area described as LEA2.
DC4	Nos. 553-637 Lea Bridge Road is within the designated boundary of DC4.
<b>Inset Maps</b>	
South Chingford DC2	No. 95 Old Church Road E4 is part of the designated "Secondary Frontage".
Wood Street DC3	The frontage between Nos. 147-155 Wood Street E17, should read as "Primary Frontage" not as "Secondary Frontage".
Bakers Arms DC4	Nos. 553-637 Lea Bridge Road is within the designated boundary of DC4.
Highams Park NC8	The frontage between Nos. 29-33 Winchester Road is excluded as part of the designated "Secondary Frontage".
