

LONDON BOROUGH OF WALTHAM FOREST TRAFFIC MANAGEMENT ORDER

The Waltham Forest (Charged-For Parking Places) (Amendment No. 135) Experimental Order 2022

Made 1st July 2022

Coming into operation see Article 1.1

The Council of the London Borough of Waltham Forest, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 9 and 10 of the Road Traffic Regulation Act 1984¹, as amended and all other powers enabling, hereby makes the following Order:-

1. Citation and Commencement

- 1.1 This Order shall come into operation for the purposes of all provisions of this Order on 8th July 2022.
- 1.2 This Order may be cited as The Waltham Forest (Charged-For Parking Places) (Amendment No. 135) Experimental Order 2022.

2. Interpretation

2.1 In this Order

"Council" means the Council of the London Borough of Waltham Forest;

"the Order of 2019" means The Waltham Forest (Charged-For Parking Places) Order 20192.

- 2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 2.3 Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2019 shall have the same meaning as in that Order.

3. Amendment to the Order of 2019

- 3.1 Whilst this Order continues in force and without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2019 shall have effect as though:
 - (a) in Schedule 3 to that Order, for the item numbered 12 in the table headed "PART LXI CANN HALL NORTH (CHN) CPZ (E11 streets)", there was substituted the item similarly numbered and set out in columns 1, 2 and 3 of Schedule 1 to this Order;

- (b) in Schedule 3 to that Order, for the item numbered 10 in the table headed "PART XLIX Wood Street East (WSE) CPZ (E17 streets)", there was substituted the item similarly numbered and set out in columns 1, 2 and 3 of Schedule 2 to this Order;
- (c) in Schedule 3 to that Order, for the item numbered 6 in the table headed "PART XXVI Walthamstow Market West (MW) CPZ (E17 streets)", there was substituted the item similarly numbered and set out in columns 1, 2 and 3 of Schedule 3 to this Order; and
- (d) there were added to Schedule 4 to that Order the items numbered 53 to 55 (inclusive) and set out in columns 1, 2 and 3 of Schedule 4 to this Order.

7. Modification

7.1 In pursuance of section 10(2) of the Road Traffic Regulation Act 1984, the Corporate Director of Neighbourhoods of the London Borough of Waltham Forest's Resident Services for the time being, or some person authorised in that behalf by him, may, if it appears to him or that person essential in the interests of the expeditious, convenient and safe movement of traffic, or of suitable and adequate parking facilities on the highway, or for the preserving or improving the amenities of the area through which any road affected by this Order runs, after consultation with the Portfolio Holder for Environment, modify or suspend this Order or any provision thereof.
