Introduction and Background

Waltham Forest Borough Council has undertaken a review of its polling district and polling places.

Under the provisions within the Electoral Registration and Administration Act 2013, the previous statutory review of all the polling districts and polling places in Waltham Forest was undertaken in 2019.

The Local Government Boundary Commission for England (LGBCE) has since reviewed all of the ward boundaries in Waltham Forest. The Waltham Forest (Electoral Changes) Order 2021, to implement recommendations made by the LGBCE for new electoral arrangements in Wandsworth, was made on 17 May 2021.

New ward arrangements for Walthamstow have now successfully completed a 40-day period of Parliamentary scrutiny and will come into force at the local elections on 5 May 2022. The final recommendations can be found on the LGBCE site here.

The number of wards will increase from 20 to 22, whilst the number of elected Councillors will remain at 60. Waltham Forest will have 16 three-member wards and 6 two-member wards.

As a result of this a further review of the polling districts is required before the changes are implemented in time for the full local council elections to be held on Thursday 5 May 2022.

A Notice of Review of Polling Districts and Places was published on 17 November 2021 seeking representations and views from residents, political parties, local councillors and persons or groups possessing particular expertise in relation to access to possible polling places. Representations, comments and feedback is sought on any aspect of the proposed polling districts or polling places set out in this report. The aim of the review is to ensure that:

- All electors have as reasonable facilities for voting as are practicable in the circumstances; and that
- So far as is reasonable and practicable that the polling places are accessible to all electors having regard to the accessibility needs of disabled persons
- To attempt to take into account current polling districts forming new polling districts or a major part thereof, where this can be achieved to ensure continuity where possible
- To attempt to take into account natural boundaries for example railway lines, major roads and rivers.

The deadline to respond to this consultation is 1 December 2021.

Roles and responsibilities and definition of terms The Council

The statutory responsibility for reviewing UK Parliamentary polling districts and places rests with each relevant local authority in Great Britain for so much of any constituency as is situated in its area.

The decision to make changes to polling districts and polling places will be make at a meeting of the full Council.

The Electoral Registration Officer (ERO)

Where a local authority makes any alterations to the polling districts within its area, the ERO must amend the register of electors accordingly – either on a notice of alteration by publishing a revised register or by publishing a revised register. The changes to the register take effect on the date that the ERO publishes a separate notice stating that the alterations have been made, which should be done to coincide with the publication of a notice of alteration/publication of a revised register.

Waltham Forest intend to republish the revised register of electors based on the new polling scheme on 4 January 2022. The last such register based on the existing wards will therefore be published on 1 December 2021.

The (Acting) Returning Officer

The election rules require the (Acting) Returning Officer to decide how many polling stations are required for each polling place and they must allocate electors to the polling stations in such a manner as they think most convenient.

Accessibility Considerations

The Council has a duty to ensure the accessibility of all polling places to disabled voters and has considered this for all polling places as part of this review. Specifically, the Council has given consideration to the Scope 2020 report 'Polls Apart 2010: Opening Elections to Disabled People'. The main physical access issues identified by scope which have been considered as part of this review are:

- Polling places with steps into the entrance
- Narrow doorways and corridors
- Lack of space within the polling place to manoeuvre motorised wheelchairs
- Lack of space and secrecy for electors and their companions to discuss the elector's choice of vote
- Lack of low level polling booths that provide voters with he confidence that they can cast their vote in secrecy
- Lack of chairs to enable people to rest
- Inadequate lighting

Unless explicitly discussed in the comments for each polling district, all polling places meet these requirements either through the existing infrastructure of the building or through the provision of temporary auxiliary aids to improve accessibility.

All polling stations are issued with low level polling booths with secrecy screens and temporary ramps are deployed where required. Polling station accessibility is kept under review in advance of each election through inspections and between elections through elector surveys and feedback.


New Wards Effective May 2022

Below is a table of all the new wards. This also shows how many Councillors will be elected to represent each ward. Some of these new wards sit within more than one existing parliamentary constituency. Currently proposed parliamentary constituencies as per the initial proposals published by the Parliamentary Boundary Commission for England do not change the current arrangement of wards within parliamentary constituencies.

These different constituencies (both existing and proposed) need to be taken account of within the new polling scheme. This is to ensure that we can identify electors who, whilst they share a local government ward, may be in different parliamentary constituencies. To do this we have either created sub/split polling districts or polling districts that are smaller than the norm to be able to properly account for and administer their particular circumstances.

The ward boundary has changed slightly in the north, giving one road to Leytonstone Ward and significantly in the west, taking in part of the old Cathall Ward. This has led to the creation of a fourth polling district. The ward falls entirely within the Leyton & Wanstead parliamentary constituency.

AAL

A change to AAL is proposed by moving the polling place from Acacia Nursery School to the Weslyan Christian Centre. This removes the need to close the nursery, which is no longer suitable due to internal changes to the building and furniture.

ABL

No changes are proposed. Cann Hall Methodist Church has been used for some time by residents in the area and does not give rise to complaints at elections.


ACL

No changes are proposed. Jenny Hammond Primary School has been used for all elections since 2015 with no problems identified. Whilst the Council is looking to find alternatives to schools where possible, there are no suitable alternatives within the proposed district or nearby that would serve electors as well.

ADL

This new polling district was formerly part of Cathall Ward. The proposed polling place has been used for electors in the area for some time with no problems identified.

A significant change to the south-eastern boundary of the ward has required changes to two polling districts (BBL and BCL) in order to adequately serve electors. This ward has reduced

to two members and part of the old Cathall Ward now forms part of the new Cann Hall Ward. The ward falls entirely within the Leyton & Wanstead parliamentary constituency.

BAL

No changes are proposed. The Epicentre has been used for some time by residents in the area and does not give rise to complaints at elections.


BBL

The proposal is to create a a new polling district in this part of the ward, which was predominantly served by New Testament Assembly Church before 2022. Due to a lack of other polling places in the west of the ward, it is proposed that New Testament Assembly Church serve voters to the west (BCL) whilst voters in this district attend Holy Trinity Church, which is closer to the centre of the district and main residential areas.

BCL

This district is made up of part of three former districts served by New Testament Assembly Church, Downsell Primary School and Ellingham Employment Services. The latter two locations now fall within Cann Hall Ward and there is little other provision in the West of the Cathall Ward. The proposal is that New Testament Assembly Church (which has been used since 2019) be the polling place. It is not ideally located, being at the edge of the district but is within easy distance of all parts of the district and situated next to the densest residential part. The church has been used without complaint at previous elections.

Chapel End Ward

Significant changes to the northern boundary of the ward have consolidated it wholly to the south of the A406. Minor changes to the north western boundary have extended the ward in to the old Higham Hill and William Morris Wards to balance the change. The ward falls entirely within the Walthamstow parliamentary constituency.

CAW

A minor change is proposed to the polling district boundary (outside of the extension west as a result of the ward boundary review). This would bring the proposed polling place at St John's church into the polling district replacing the neighbouring Sir George Monoux College. The church was used at the most recent elections in 2021 without complaint. Whilst not ideally placed at the eastern limit of the district, the church avoids the use of schools in the area including Hillyfield Primary Academy (Park Site) which would have to close if used.


CBW

No changes are proposed. The Spruce Hill Baptist Church has been used for some time by residents in the area and does not give rise to complaints at elections.

CCW

No changes are proposed. The YMCA has been used for some time by residents in the area and does not give rise to complaints at elections. Ideally Fellowship Square will be able to host a polling place once works on the site have ceased.

Chingford Green Ward

A minor change to the central southern boundary of the ward has taken in part of the old Endlebury Ward, otherwise no changes are proposed to boundaries or polling places in the ward. The ward falls entirely within the Chingford & Woodford Green parliamentary constituency.

DAC

No changes are proposed. Despite trialling an alternative at the adjacent scout hall in 2019, it was not found to be suitable due to poor accessibility. Yardley Primary School remains the only accessible and suitable polling place in the west of this ward.


DBC

No changes are proposed. North Chingford Methodist Church has been used for some time by residents in the area and does not give rise to complaints at elections.

DCC

No changes are proposed. The 15th Chingford Scout Group Hall has been used for some time by residents in the area and does not give rise to complaints at elections.

There have been significant changes to the ward which will be represented by two Councillors in future. Part of the north east now forms part of Chingford Green Ward, whilst a significant portion of the south west has been absorbed into Valley Ward. The resulting changes have resulted in the former polling places to 2/3 districts in the ward now falling within neighbouring wards. The ward falls entirely within the Chingford & Woodford Green parliamentary constituency.

EAC


Changes to the boundary are proposed to serve voters on the eastern edge of the ward which was formerly a separate polling district. That district now falls partly within the new Chingford Green ward along with the former polling station (Kings Road Baptist Church). There are no identified alternatives in this part of the ward aside from Chingford Horticultural Society Hall which has been investigated previously but found to be unsuitable. No changes

are proposed to the polling place. Ridgeway Evangelical Church has been used for some time by residents in the area and does not give rise to complaints at elections.

ECC

The proposed polling place for this district is Parkside Primary School which replaces All Saints' Church (Old Church). The previous polling place now falls within the Valley Ward. No suitable alternatives to the school have been identified in the area. The school is accessible and is situated toward the centre of this district.

There have been significant changes to the ward which will has been extended west taking part of the old Leyton Ward. Part of the north now forms part of Hoe Street Ward. The resulting changes have resulted in the creation of a new polling district to take in the new area to the west. The ward falls entirely within the Leyton & Wanstead parliamentary constituency.

FAL

No changes are proposed. The Cornerstone Church & Community Centre has been used for some time by residents in the area and does not give rise to complaints at elections.

FBL

St Andrew's Church is proposed as a replacement for Gwyn Jones Primary School as the Council seeks alternatives to schools going forward. The church was used at the Greater London Mayoral and Assembly elections in 2021 without complaint and is accessible to voters although further east than the current polling place. To bring the boundary of the district east would adversely affect the distribution of electors to polling places in the ward although this may need to be revised pending development on the current Whipps Cross Hospital site.


FCL

No changes are proposed. Belmont Park School has been used for some time by residents in the area and does not give rise to complaints at elections. Alternatives to the school have been explored but there are no viable options identified that would adequately service residents in this part of the ward.

FDL

This new district previously formed part of the Leyton Ward and was served by George Mitchell Primary School. For a number of elections the Seddon Centre has been used as an alternative to the school without complaint. As part of the move away from schools, it is proposed that the Seddon Centre be the new polling place for this district.

Grove Green Ward

There has been one minor change to the boundary of the ward which has been extended to the railway line in the far eastern corner of the ward. There has been one minor change to

the district in this part of the ward to account for this, otherwise no changes have been proposed to polling district boundaries. The ward falls entirely within the Leyton & Wanstead parliamentary constituency.

GAL

No changes are proposed. Dawlish Primary School has been used for some time by residents in the area and does not give rise to complaints at elections. As part of the move away from the use of schools, the Council have been unable to identify any suitable alternative premises in this part of the ward to serve electors.


GBL

The proposed polling place for this part of the ward is Christ Apostolic Church on Grove Green Road. Whilst on the edge of the district, the church replaces Newport Primary School as part of the Council's move away from the use of schools. The church was used at both the Greater London Mayoral and Assembly elections and the Grove Green by-election in 2021 without complaint.

GLC

No changes are proposed. Leyton Trinity Methodist Church has been used for some time by residents in the area and does not give rise to complaints at elections.

This is a new ward represented by 2 Councillors. The ward is formed of parts of the old Hale End & Highams Park and Chapel End Wards and is split across the Chingford & Woodford Green and Walthamstow parliamentary constituencies.

HAC

The polling district remains unchanged from the old Hale End & Highams Park Ward as does the polling place, Highams Park Baptist Church. The church has been used as the polling place since 2017 with no complaints by residents and prevents the closure of the nearby Selwyn Primary School.

HBC

The polling district remains unchanged from the old Hale End & Highams Park Ward as does the polling place which was previously called Highams Park United Reform Church. The venue has been used without complaint for a number of years.


HCC

The polling district remains unchanged from the old Hale End & Highams Park Ward as does the polling place, Oakhill Primary School. The only viable alternative venue in this part of the ward is Brookfield House School, which is avoided in order to avoid closure of the specialist unit at the school. Consideration has been given to combining the HBC and HCC polling districts but the Seventh Day Adventist Church is not located well for voters at the far east of the district and is unlikely to be able to support the increase in voter traffic.

HCW

This district was formerly part of the Chapel End ward and falls within the Walthamstow parliamentary constituency, unlike the rest of the ward which falls within Chingford & Woodford Green parliamentary constituency. It is proposed that the polling place remain the same as it has been used without complaint for a number of years. Whilst there is argument that the polling place could be combined with Highams Park Baptist Church, it is felt that voters should be kept separate for the administration of parliamentary elections.

Hatch Lane & Highams Park North Ward

This is a new ward represented by 3 Councillors made up of parts of the old Hale End & Highams Park, Hatch Lane, and Larkswood Wards. The ward falls entirely within the Chingford & Woodford Green parliamentary constituency.

IAC

Two former polling districts have been combined to reduce the need to use two schools in the area. The proposed polling place is Longshaw Primary School which has been used for a number of years with no problems identified. The proposed combined district would place the polling station further from electors at the far north east of the ward but in the centre of the largest density of housing in the district. There are no suitable alternatives other than schools in this part of the ward.


IBC

No changes are proposed. St Andrew's Church has been used for some time by residents in the area and does not give rise to complaints at elections.

ICC

This district now takes in part of the old Larkswood ward to the west of the railway line. The proposed polling place of Handsworth Primary School has been the polling place for this area for many years without complaint. The extension makes this one of the largest polling districts in the borough which will be kept under review.

The ward has been significantly altered by the creation of the new St James Ward to the west and has been extended south into the former Markhouse Ward. The ward falls wholly within the Walthamstow Constituency and is expected to increase in population significantly with development in the area.

JAW

Parts of two former districts have been combined to create a new district with St Michael and All Angels Church as the proposed polling place. The polling station has been used without complaint for a number of years and would prevent the use of Stoneydown Park Primary School (infants site).


JBW

Minor changes have been made to the district to account for changes to the west of the ward. Harmony Hall has been used as the polling place for this area for a number of years and it is proposed that it should continue to be the polling place for this district. This district is likely to experience significant population growth over the coming years and will be kept under review in case additional polling places are required. Walthamstow Library is a possible option should there become a need to split this district in future.

JCW

This district formerly formed part of the Markhouse Ward. A new polling place at South Grove Free Presbyterian Church has been identified to serve voters in the area. The alternative polling place is South Grove Primary School which has been avoided in order to avoid disruption to schools.


The ward has been partially altered by the creation of the new St James Ward to the south west and has given part of the eastern edge to Chapel End Ward. The ward is falls wholly within the Walthamstow Constituency

KAW, KBW, KCW

All three polling places have been used for elections since 2015 with no problems identified for voters. No changes are proposed to the polling places in these districts, the boundaries of which remain unchanged aside from the outer ward boundaries described above.

It is noted that all three districts require the use of schools. Despite significant work to identify alternative polling places, this highly residential area has no suitable alternatives. In KCW district some potential alternatives were explored in the Uplands Business Park area but these were found to be unsuitable due to accessibility issues including a lack of consistent paved pedestrian access.

The ward has been partially altered by giving away the area to the west of Hoe Street to the new Markhouse Ward and extending south to bakers arms taking in part of the old Forest ward. The ward now falls within two parliamentary constituencies with the majority in Walthamstow but the small addition to the south falling in Leyton & Wanstead.

LAW

At the 2021 Greater London Mayoral and Assembly elections the YMCA was the polling place for this district to avoid the use of Emmanuel Community School. The hall at the YMCA is large enough to support 4 polling stations and it is proposed that this continue. The district has been amended to support ease of access by voters by ensuring that it serves streets that connect directly to Forest Road and the northern part of Hoe Street.

LBW

At the 2021 Greater London Mayoral and Assembly elections Vestry House Museum was the polling place for this district to avoid the use of Church Hill Nursery School without any complaint. The district boundary has been amended to better serve voters.


LCW

Central Baptist Church has been a polling place in this ward for a number of years without complaint and it is proposed that this continue. The district has been amended to reduce traffic at Ghousia Hall and to accommodate Vestry House Museum.

LDW and LEL

Ghousia Hall has been a polling place since the 2019 review of polling districts and places and has been used without complaint at all elections since 2018 following the closure of the previous polling place. The boundary has been redrawn to accommodate both districts, one of which falls within the Walthamstow parliamentary constituency and the other in Leyton & Wanstead (hence the smaller allocation of voters to LEL).

There have been significant changes to the boundaries of the southern edge of the ward, which has taken in part of the old Chapel End Ward. The ward now falls predominantly within the Chingford & Woodford Green parliamentary constituency with the new addition in the south falling within the Walthamstow parliamentary constituency.

MAC & MBC

There are no proposed no changes to the polling places and boundaries of these district. The polling places have been used without complaint since 2015.

MCC

St Edmunds Church was previously the polling place for this district until 2015, following which the polling place moved to Ainslie Wood Primary School. In order to avoid the use of schools at the 2021 Greater London Mayoral and Assembly elections, the polling place returned to St Edmunds Church. It is proposed that the return be made permanent to avoid disruption to the school.

MDC & MEW

Highams Park and Chingford Synagogue replaced South Chingford Foundation School at the 2021 Greater London Mayoral and Assembly Elections and it is proposed that this arrangement continue in order to avoid disruption to the school. It is proposed that the polling place serve twodistricts, one of which falls within the Chingford & Woodford Green parliamentary constituency and the other in Walthamstow (hence the smaller allocation of voters to MEW).
