- 1) NOTICE IS GIVEN that the London Borough of Waltham Forest (hereinafter referred to as "The Council") on 9th February 2023 made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.
- 2) The general effect of the Orders will be to:
 - (a) convert a section of controlled parking zone permit parking space and provide an additional electric vehicle charging space (to accompany 2 already in place) in the following location (total length of charging space shown in brackets): Fillebrook Road E11 (LSW CPZ) (5.5 metres (1 vehicle)) on the south-east side, adjacent to No. 16 Drayton Road for approximately 6.5 metres; and
 - (b) to provide that the electric vehicle charging space referred to in paragraph (a) above would be available 'at all times' for the use of any electric vehicles only whilst charging at an adjacent electric vehicle charging post, limited to a maximum period of 4 hours, between 8am and 6.30pm on Mondays to Sundays inclusive;

[Note: there would be a 1 metre length separating bays in each parking place on which a charging post would be located];

- 3) Copies of the Orders, which will come into operation from 13th February 2023 and all other relevant documents can be inspected until the expiration of a period of six weeks from that date on request by either emailing traffic.scheme@walthamforest.gov.uk or visiting (*by appointment) the Highways and Traffic Management Office, Low Hall, Argall Avenue, London, E10 7AS during normal office hours on Mondays to Fridays inclusive, or alternatively documents can be viewed online at: https://www.walthamforest.gov.uk/content/road-traffic-schemes-and-consultations.
- 4) Any person desiring to question the validity of the Order or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Order may, within six weeks of the making of the Order, make application for the purpose to the High Court.
