- 1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Waltham Forest on 24th March 2023 made the above-mentioned Orders under sections 9, 10 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended. The experimental Orders mentioned above will come into force from 31st March 2023 and may continue in force for up to 18 months.
- 2. The general effect of the experimental Orders will be:
 - (i) in Scarborough Road (SB):
 - (a) to close to vehicular traffic (including motorcycles) (except pedal cycles) the full width of the **highway between a point 1.4 metres south-east of the common boundary of Nos. 5 and 7 SB south-eastwards for 4 metres (all vehicular traffic will be prohibited from proceeding or entering 'at all times');
 - (b) provide double yellow line "at any time" waiting restrictions across the south-east and north-west facing ends of the closure mentioned in item 2(i)(a) at 90 degrees to the north-east and south-west kerb lines;
 - (c) **south-west side** reduce permit parking space between a point 1.4 metres south-east of the common boundary of Nos. 5 and 7 SB and the common boundary of Nos. 1 and 3 SB and provide, in the area of displaced permit parking space, double yellow line "at any time" waiting restrictions; and
 - (d) **north-east side** reduce permit parking space between the common boundary of Nos. 8 and 10 SB and the common boundary of Nos. 6 and 8 SB and provide, in the area of displaced permit parking space, double yellow line "at any time" waiting restrictions.
 - (ii) remove the left-turn ban for vehicular traffic travelling eastbound in **Grove Green Road** from turning left into **Scarborough Road**;
 - **Note: the designation of the closure to vehicular traffic (modal filter) mentioned above will operate across the full width of the highway boundary including the footways/pavements. Exemptions apply.
- 3. - **4.** Where it appears necessary for certain purposes, an authorised officer of the Council may, in pursuance of section 10(2) of the Road Traffic Regulation Act 1984, modify or suspend any provision of the experimental Traffic Orders while they are in force.
- 5. The Council will be considering in due course whether the provisions of the experimental Traffic Orders should be continued in force indefinitely by means of permanent Traffic Orders made under section 6, 45, 46 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984. Any person may object to the making of the permanent Orders for the purpose of such indefinite continuation within a period of six months beginning with the day on which the experimental Orders come into force or, if the Orders are varied by another Order or modified pursuant to section 10(2) of the 1984 Act, beginning with the day on which the variation or modification or the latest variation or modification came into force. Any such objection must be made in writing and must state the grounds on which it is made and be sent to: Traffic Orders, Highways, Low Hall, Argall Avenue, London, E10 7AS, or by emailing: traffic.scheme@walthamforest.gov.uk quoting reference T8(23) Scarborough Road E11 Modal Filter and removal of left hand turn ban in Grove Green Road. Any objection may be communicated to, or be seen by, other persons who may be affected.

6. If any person wishes to question the validity of any the Orders or of any of their provisions on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Orders are made, apply for the purpose to the High Court.
