**THE WALTHAM FOREST (TEMPORARY WAITING AND LOADING RESTRICTIONS) (FARNAN AVENUE E17) ORDER 2023**

Coming into operation 6<sup>th</sup> April 2023

The Council of the London Borough of Waltham Forest, (hereinafter referred to as "the Council") being the Traffic Authority for certain roads in that borough is satisfied that waiting and loading restrictions should be imposed to allow safe access, egress for construction vehicles in association with development works in the Waltham Forest town hall grounds E17.

The Council in exercise of its powers under section 14(1) of the Road Traffic Regulation Act 1984(a) as amended by the Road Traffic (Temporary Restrictions) Act 1991(b) and all other enabling powers hereby makes the following Order:

1. This Order shall come into operation on **6<sup>th</sup> April 2023** and would be valid until the need for safe access and egress for construction vehicles to and from the development works site in the Waltham Forest Town Hall grounds E17 is concluded, and may be cited as The Waltham Forest (Temporary Waiting and Loading Restrictions) (Farnan Avenue E17) Order 2023.
2. No person shall, at such times and to such extent as regulatory traffic signs are displayed cause or permit any vehicle to wait or load, for any purpose, between the hours of 9.30 a.m. and 3.30 p.m. Mondays to Saturdays (inclusive) in Farnan Avenue E17:
  - (a) on the **west side**:
    - i. between a point 16 metres north of northern kerb line of Forest Road and a point 3 metres north of the southern boundary of No. 2c Farnan Avenue; and
    - ii. between a point 3 metres south of common boundary of Nos. 2 and 2d Farnan Avenue and the common boundary of Nos. 22 and 24 Farnan Avenue.
  - (b) on the **east side**:
    - i. between a point 19 metres north of northern kerb line of Forest Road and a point 3 metres north of the southern boundary of No. 2c Farnan Avenue; and
    - ii. between a point 4 metres south of the common boundary of Nos. 6 and 8 Farnan Avenue and a point 2 metres south of the common boundary of No. 14 and 16 Farnan Avenue;
3. No person shall, at such times and to such extent as regulatory traffic signs are displayed cause or permit any vehicle to wait or load, for any purpose "at any time" in Farnan Avenue E17, on the **west side**, adjacent the flank wall of No. 627 Forest Road.
4. No person shall, at such times and to such extent as regulatory traffic signs are displayed cause or permit any vehicle to load, for any purpose between the hours of 9.30 a.m. and 3.30 p.m. Mondays to Saturdays (inclusive) in Farnan Avenue E17 on the **west side**, outside Nos. 2c and 2d Farnan Avenue;
5. Nothing in this Order shall apply:
  - (a) in relation to a vehicle being used for ambulance, fire brigade or police purposes; or
  - (b) in respect of anything done with the permission or at the direction of a police constable in uniform or a civil enforcement officer.
