

## LONDON BOROUGH OF WALTHAM FOREST

### ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)

#### THE WALTHAM FOREST (TEMPORARY WAITING AND LOADING RESTRICTIONS) (FARNAN AVENUE E17) (NO. 1) ORDER 2023 (TT28(23))

1. The Council of the London Borough of Waltham Forest **HEREBY GIVES NOTICE** that it intends on making an Order to allow safe access, egress for construction vehicles in association with development works in the Waltham Forest town hall grounds E17.
  2. The general effect of the Order would be, in **Farnan Avenue (FA) E17**
    - (a) to suspend Permit and Free short stay parking space between the hours of 9.30 a.m. and 3.30 p.m. Mon - Sat (inclusive) and provide waiting and loading restrictions operating between the hours of 9.30 a.m. and 3.30 p.m. Mon-Sat (inclusive):
      - i. on the **west side**:
        1. between a point 16 metres north of northern kerb line of Forest Road and a point 3 metres north of the southern boundary of No. 2c FA; and
        2. between a point 3 metres south of common boundary of Nos. 2 and 2d FA and the common boundary of Nos. 22 and 24 FA.
      - ii. on the **east side**:
        1. between a point 19 metres north of northern kerb line of Forest Road and a point 3 metres north of the southern boundary of No. 2c FA; and
        2. between a point 4 metres south of the common boundary of Nos. 6 and 8 FA and a point 2 metres south of the common boundary of No. 14 and 16 FA
    - (b) on the **west side**,
      - i. suspend a Car Club parking place adjacent No. 627 Forest Road and replace with double yellow line "at any time" waiting and loading restrictions;
      - ii. provide loading restrictions operating between the hours of 9.30 a.m. and 3.30 p.m. Mon-Sat (inclusive) outside Nos. 2c and 2d FA (adjacent the drop kerbs),
- all at such times and to such extent as regulatory signs are displayed or, where applicable, covered.
3. Once the new Order is made THE WALTHAM FOREST (TEMPORARY WAITING AND LOADING RESTRICTIONS) (FARNAN AVENUE E17) ORDER 2023 would be revoked.
  4. Vehicles waiting, loading, stopping or parking in disregard of this Order would be removed.
  5. The new Order and the revocation of the Order mentioned in item 3 preceding would come into force on **18<sup>th</sup> May 2023** and will remain in operation until the need for safe access and egress for construction vehicles to and from the development site in the Waltham Forest Town Hall grounds E17 is concluded.
  6. The part-time waiting and loading restrictions would only apply at such times and to such extent as shall be indicated by the placing and covering of the appropriate traffic signs (CPZ entry sign plates would govern waiting restrictions without signs on the kerb side (except "at any time" waiting restrictions).
  7. In so far as any provision imposed by the Order conflicts or is inconsistent with any provision of any Order made under the Road Traffic Regulation Act 1984, as amended, in the London Borough of Waltham Forest the provisions of the intended Order shall prevail only at such times and to such extent as regulatory signs are displayed in relation to the measures set out in this Order.
