The Waltham Forest (Charged-For Parking Places) (Amendment No. 169) Order 2023

Made 4th May 2023

Coming into operation see Article 1.1

The Council of the London Borough of Waltham Forest, after consulting the Commissioner of Police of the Metropolis, in exercise of the powers conferred by sections 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984(a), as amended and all other powers enabling, hereby makes the following Order: -

1. Citation and Commencement

- 1.1 This Order shall come into operation for the purposes of all provisions of this Order on 8th May 2023.
- 1.2 This Order may be cited as The Waltham Forest (Charged-For Parking Places) (Amendment No. 169) Order 2023.

2. Interpretation

2.1 In this Order

"Council" means the Council of the London Borough of Waltham Forest;

"the Order of 2019" means The Waltham Forest (Charged-For Parking Places) Order 20191.

- 2.2 Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment.
- 2.3 Unless the context otherwise requires, any expression used in this Order which is also used in the Order of 2019 shall have the same meaning as in that Order.

3. Amendment to the Order of 2019

3.1 Whilst this Order continues in force and without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the Order of 2019 shall have effect as though:

- (a) in Schedule 3 to that Order, for the item numbered 8 in the table headed "PART LXVIII WALTHAMSTOW CENTRAL (WSC) CPZ (E17 streets)", there was substituted the item similarly numbered and set out in columns 1, 2 and 3 of Schedule 1 to this Order;
- (b) there were added to Schedule 4 to that Order the item numbered 56 (inclusive) and set out in columns 1, 2 and 3 of Schedule 2 to this Order.
