You did it: Victory for Whipps Cross

After years of uncertainty the **Government has announced** that it will now proceed towards construction and fund a new hospital at Whipps Cross to serve more than 400,000 people across Waltham Forest, Redbridge, and parts of Essex.

It follows decades of campaigning to save the crumbling Victorian era hospital and create a new Whipps Cross that meets the needs of the community in the 21st century.

The Leader of Waltham Forest Council, Cllr Grace Williams. thanked everyone who has supported the campaign.

She said: "For decades Waltham Forest Council has been campaigning alongside residents and hospital staff for improvements to Whipps Cross. The importance of this issue for local people was demonstrated by the 11,000 people who signed our Whipps Won't Wait Campaign petition.

"Thank you to everyone who got involved – your support has been vital in showing the Government the strength of local feeling on this issue.

"I also can't express my gratitude enough to the wonderful nurses, doctors, and NHS support staff who have worked so hard for so long in dilapidated buildings.'

The Whipps Won't Wait Campaign seized on a once-in-alifetime opportunity to transform the hospital and the wider site to serve borough residents for generations to come, improving health outcomes and reducing inequalities whilst providing much-needed new homes.

Now that the funding has been secured, Whipps Cross will become a state-of-the-art 'smart' hospital that will vastly improve the experience for patients and staff alike.

"We will at last have a hospital that is fit for purpose for the 21st century and of which staff can rightly be proud"

There will be more clinical space, two new operating theatres, taking the total to 14, which will be located next to recovery rooms, and a day unit to better care for patients. On top of this there will be twice as many CT and MRI scanners.

The improved, greener site will encourage more cycling, walking and public transport usage with the ambition to deliver net zero carbon emissions



The urgency of the improvement work was demonstrated in July 2021 when serious flooding closed A&E and prevented hundreds of essential operations. Some of the most vulnerable patients had to be removed from their hospital wards in pitch dark.

Cllr Williams added: "The Government has said that Whipps Cross will now go ahead. That means we will at last have a hospital fit for the 21st century, that will serve the needs of the people, and a world class facility that works for staff and patients alike.

"I know the affection local people have for Whipps Cross. Many residents will have been born, had babies of their own, and had relatives cared for at the hospital.

"We now have the opportunity to build on the emotional attachment the community has for Whipps and create a legacy for future generations.

"We will hold the Government to account to make sure this happens without further delay and the money they've promised is used well to meet the needs of residents."

An additional benefit of the funding announcement is that the wider Whipps Cross site will be transformed once the new hospital opens to provide up to 1,500 new homes — 50 per cent of which will be affordable – alongside a community health building, new green and public spaces, and retail and leisure facilities for the whole community.

My Neighbourhood

If you had £10,000, how would you improve your local neighbourhood?

Let's Talk about the improvements you want to see

Let's Talk, the council's neighbourhood improvement programme, will run through the summer for residents to suggest practical improvements to their local area.

The council is keen to capture as many ideas as possible from a range of Waltham Forest residents before the deadline of Sunday 10 September 2023. The chosen improvements will be decided by ward councillors, and decisions will be announced on Friday 24 November. The projects will start being installed from December onwards.

"We want all residents to have a voice – to tell us what needs to be done to make a positive change in their local area"

Cllr Alistair Strathern, Cabinet Member for 15-Minute Neighbourhoods at Waltham Forest Council, said "If we want to make the right improvements to our neighbourhoods, we need to listen to our residents. We want all residents to have a voice - to tell us what needs to be done to make a positive change in their local area. We will be out and about in the borough this summer, listening to as many of you as possible, finding out what is really important to each of the communities that make Waltham Forest so special, and learning how we can work together to make improvements that will have an immediate and long-lasting impact on our neighbourhoods."

Physical improvements including green projects and better street furniture are welcome. From creating vibrant community parklets, to widening cycle lanes for safer and greener commuting, practical and specific suggestions will really help councillors understand what changes are needed. Every suggestion counts and could be the spark that ignites positive change.

There are several ways to get involved. Ideas can be submitted through the online survey, where you can use the 'drag and drop' pin to mark on a map where the change is, before typing your suggestion into the box.

If you prefer to have your say in person, libraries across the borough have received postcards with space for writing down your idea, which can then be dropped into the post boxes. Councillors and engagement teams will also be around the borough this summer to take your suggestions too. The council has already received some great ideas.

Katherine P from Leyton suggested "Biodiversity installation. In front of the park there is a space where the alcove is" on Leyton High Road, while Jey from Chingford said "Install outdoor fitness equipment in local parks or recreational areas" by Cart Lane. Let's talk and work together to keep improving Waltham Forest for everyone.

Healthy Start Miss

Getting a Healthy Start

This scheme has helped me greatly during the winter, when we had difficult weeks because of the cost-of-living crisis.





The Healthy Start card helps Selina make sure her daughter has access to nutritious food

"My name is Selina and I live in Chingford. I have a two-year-old girl named Hannah.

"I first heard about the Healthy Start Scheme a year and a half ago through the Chingford Baby Clinic at Hannah's six-months checkup, and I signed up online.

"The Healthy Start card is really easy to use and works in any shop accepting Mastercard payments. I usually use the card to buy a selection of essential products such as milk, as well as fresh food at Asda or Sainsbury's, where the Healthy Start card is accepted. I have also recently used it in the local fruit and vegetable store, where I can pick up fresh produce, and support the local area at the same time.

"Money is added onto my Healthy Start card every four weeks and I get £4.25 each week based on Hannah's age. It has helped me to stay on top of my finances as I am able to calculate the sum into my monthly spending. It is very reassuring, especially in these difficult times, to know I always enough for Hannah's essential foods.

"The Healthy Start Scheme has allowed me to always make sure my daughter has nutritious food, essential for her to grow healthy, which all contributed to her great development and the cheeky character she is growing into."



If you're eligible, you will be sent a Healthy Start card with money on it that you can use in UK shops displaying the Mastercard logo. Money will be added automatically onto this card every four weeks.

You can use the Healthy Start card to buy:

- Fresh, tinned or frozen fruit
- Fresh, tinned or frozen vegetables or pulses
- Cow's milk
- Infant formula

What will I get?

- £8.50 per week for each baby under one
- £4.25 per week for each child between one and three years old
- £4.25 per week if you are pregnant (from week ten)
- Free vitamins that you can collect at your local Family Hub

Who is eligible?

If you're over 18, you might be eligible for a Healthy Start card if you are at least ten weeks pregnant or you have at least one child under four. You must also be receiving any of the following:

- Child Tax Credit (only if your family's annual income is £16,190 or less)
- Income Support
- Income-based Jobseeker's Allowance
- Pension Credit (which includes the child addition)
- Universal Credit (only if your family's monthly take-home pay from employment is £408 or less)

If you're under-18 and pregnant or have a child under four, you will qualify even if you don't get any benefit

How estate residents are making big changes in their areas

The council is investing £1 million into its Positive Places programme.

The funding is available for resident led improvement works to the environment in and around their housing estates.

A few projects we've completed so far:

- a Multi-Use Games Area (MUGA) with a surrounding mural, plus a new community growing allotment in partnership with Organic Lea on Stocksfield Road Estate
- a play area and community room on the Aldriche Way
- a redesigned Attlee Terrace playground with lots more play equipment, with new resurfacing as well as benches for parents to relax
- Lena Kennedy Close, Park Court and Cecil House residents welcomed new security measures
- added new benches, planters and landscaped green spaces across the borough including Cherrydown and Marmion Avenue, Holmcroft House and most recently at Church Hill Road courtyard garden

Juli, a resident on the Stocksfield Road Estate, was pleased with recent works in her area.

"The Positive Places programme has provided some brilliant investment in our local community", she said.

"We are really pleased with our new benches and planters. Thank you!"

"The developed space has taken on many forms, originally it was a dull, grey and dingy two storey car park and a gravelly play area.

"But we were delighted to celebrate the opening of the refurbished Multi-Use Games Area (MUGA).

"It provides a fantastic opportunity for the children













to play and take part in lots of fun activities. During an engagement day we also helped design and input into the mural and artwork now surrounding the MUGA.

"We are very pleased to see how far the space has progressed and would like to thank the team who has helped deliver this for us!"

Rachel, a resident near Cherrydown and Marmion Avenue, was also happy with improvements near her. "We are really pleased with our new benches and planters.

It is a fantastic space for residents to come together, catch up in the evening while others used the benches for arts and crafts, jewellery making and knitting. Thank you!"

Next, we are focussing on more communal garden projects to allow residents at Tenby Court, Amber Avenue and our sheltered housing schemes Pelly Court and Lime Court to continue enjoying the summer. Keep your eyes peeled for more updates soon.

How neighbourhood officers help to keep the streets safe

Working with residents across the borough

The Council employs around 3,000 people in all sorts of different jobs, from social workers to street cleaners and much more in between.

Neighbourhood officers act as champions for the ward they are assigned to, helping with a range of issues including street cleansing, noise nuisance and enviro-crime.

They patrol their areas and help residents to report problems such as fly-tipping to the street cleansing team as they engage with local people about their concerns.

We spoke with a neighbourhood officer to find out more about their day-to-day work.

Chris G, Neighbourhoods Team Manager (North)

Chris manages the neighbourhood officers in the north of the borough, which includes Chingford, and is a lead officer on the Safe Streets pilot programme which is active in both Chingford Mount and South Leytonstone.

Safe Streets is a programme where the focus is on listening to communities about the local action they want, making reporting anti-social behaviour easier, and having more visible patrols on the streets.

Chris said: "One example of the Safe Streets work is Operation Melius, a targeted operation in South Leytonstone focusing on the anti-social behaviour associated with some of the garage businesses operating there. Since the operation began two months ago, we are seeing better compliance with parking regulations, waste disposal duty and other problems residents had flagged to us. We're going to keep the pressure up and hopefully keep seeing positive progress."

Young people have told us how important it is to have safe spaces to spend time in, and we're working hard to make sure young people of Waltham Forest have this available locally to their homes.



75 Years of Windrush in Waltham Forest

Fellowship Square focal point of borough-wide celebration

Waltham Forest's 25,000-strong Afro-Caribbean community were honoured in this year's jam-packed, partner-led programme culminating in a Windrush Day flag-raising ceremony in Fellowship Square, followed by the second ever Waltham Forest Windrush Festival.

2023 marks 75 years since the arrival of HMT Empire Windrush at the Port of Tilbury in 1948 and the advent of the Windrush generation in the UK.

The Windrush flag was raised above Waltham Forest Town Hall to the sound of steel drums on Thursday 22 June, with Council Leader Cllr Grace Williams speaking alongside contributions from Cllr Vicky Ashworth, Pauline Campbell, award winning Waltham Forest Council lawyer who supervises The Windrush Justice Clinic, the Waltham Forest Twinning Association, the Afro-Caribbean Elders Association and the Retired Caribbean Nurses Association.

Guests were also treated to special performances from George Tomlinson Primary School, Buxton School, and Emmanuel Community School.

Following the success of the very first Waltham Forest Windrush Festival in 2022, this year's festivities on Saturday 24 June saw Fellowship Square come alive with the very best in Afro-Caribbean music, food, history and art.

Stage programme highlights included music and dance performances from the The African Diaspora Festival Choir, WIILMA, Mbilla Arts, Downsell Primary School, and Alison Ray Dance Company, with a range of Windrush-themed arts, crafts and games workshops courtesy of Project Zero, Kimartee, Writers and Actors Forum, Age UK, The Skills Within, among others.

Cllr Grace Williams, Leader of the Council, said: "We pay tribute to the profound influence the Windrush Generation has had on our borough and beyond.

"This year's celebrations – including the second ever Waltham Forest Windrush Festival – are about both celebrating our

Afro-Caribbean heritage and acknowledging the injustice and racism suffered by the Windrush Generation."

Beyond Fellowship Square, author and educator Peter Ashan led Windrush Freedom walks in Walthamstow and North Chingford with exhibitions, film screenings, and a jam-packed libraries programme rounding out Windrush celebrations in Waltham Forest.

Design fixing meets social good

Sean Rodrigo is tackling social issues in a sustainable way

Walthamstow resident Sean Rodrigo uses design, art, and technology expertise to tackle social issues.

Sean, who owns *The Fixatorium* studio in Argall Avenue, describes it as "design fixing meets social good", focusing on challenges to help those who need it most.

Sean's work is recognisable in the community. Using his 3D printer, he created 'mini food banks' for local group PL84U Al-Suffa. These miniature houses were dotted around the borough, capturing the attention of curious locals.

"Waltham Forest is a great place to deliver these projects as the Council and local people have a real interest in my work"

He recently launched 'The Tool House', a fully accessible community workspace in the Walthamstow Pumphouse Museum that runs upcycling and repair workshops and



hosts dedicated autismfriendly sessions. Locals can use the workspace for DIY, repair, arts and crafts or 3D printing, and it is affordable or available in exchange for volunteering time.

Sean said: "We want this to be an inclusive community resource for anyone, including those who are not considered 'typical DIYers', to learn by doing. With wheelchair access and a hydraulic hoist between levels, the space is specifically designed to be inviting for everyone regardless of ability.

"For charities, schools, food banks and community groups, we offer solutions to tackle their biggest challenges using creativity and innovative technology. Waltham Forest is a great place to deliver these projects as the Council and local people have a real interest in my work and are committed to reducing waste."

- A film piece exploring invisible voices from Leytonstone
- A moving image work about the ecology of Highams Park Lake and the ancient surrounding forest
- Working with young people at Belmont Park School to create eco-arts workshops for other students
- Creative community storytelling project exploring Leyton through the eyes of a cat

Taking everything on board

Local youth group benefits from council funding



A pioneering project to help young people improve their skateboarding skills is going from strength to strength with support from the Council's Community Walking & Cycling Fund.

Everyone on Boards is a community led, not-for-profit group, founded in 2020 by Agnieszka Aga Wood. It runs a range of skateboard lessons for five to 16-year-olds at two local skateparks with the aim of empowering as many people as possible to enjoy and benefit from the sport.

Everyone on Boards has received more than £1,000 from this year's Community Walking & Cycling Fund, which has helped expand the project to reach even more young people.

Aga explains: "It has really helped us with the outreach side of things, connecting with people who might not otherwise get the chance to try skateboarding.

"It requires less equipment than some other activities, but there is still a cost involved and for many people, even a relatively low barrier to entry is enough to prevent some from trying. We really want everyone to feel that it is something they can get involved with."

Everyone on Boards has been hugely successful in expanding over the last few years with the support of the Council, seeing a 30 per cent increase in participation overall, and an amazing 70 per cent increase in the number of girls attending the activities.

Aga continues: "We want current and future generations of young people to enjoy outdoor activities, which helps build confidence and social skills.

"It also challenges people mentally and physically, and I hope it helps encourage them to make positive decisions that benefit the wider community.

"It's also really important to encourage more girls to take an active part in skateboarding regardless of background." Now in its fifth year, the Community Walking & Cycling Fund has helped more than 2,500 residents to get involved with a range of active travel projects. This year, nine unique projects offering a huge range of free, social activities to local people throughout the summer have received grants of up to £3,000 each.

Alongside Everyone on Boards, projects include Age UK Waltham Forest, which runs cycle training for those aged 60 plus; wellbeing walks with Life After Cancer; bike rides round the borough for local women, courtesy of Cycle Sisters; and JoyRiders Britain CIC, which offers summer cycling opportunities for families.

There's also JP Fix and Ride, offering DIY bike maintenance courses in Leytonstone and Chingford; CarryMe Bikes CIC, a family cycling equipment lending library; weekly bike rides from Salaam Peace and finally, The Walking Project, courtesy of Cann Hall Can.

More new homes for local people alongside neighbourhood improvements



Cllr Grace Williams, Leader of Waltham Forest Council, visited the Wood Street Families and Homes Hub to celebrate the completion of the frame and roof to the eleventh floor of the new building.

The site, on the corner of Wood Street and Forest Road, is being developed into a service centre for the local community alongside muchneeded homes for Waltham Forest residents

The building will provide 67 affordable new homes (29 for social rent and 38 for shared ownership) and space for residents to access some of the Council's most important customer-facing families and housing services. There will also be a commercial unit for a small shop or café which will provide job opportunities for local people.

"We're committed to putting residents at the heart of everything we do"

Cllr Williams said: "We're committed to putting residents at the heart of everything we do and to build better services. The topping out of Wood Street Families and Homes Hub is a huge milestone for us

all to recognise the big impact that this building will have for Waltham Forest residents. Not only will this provide new, 100 per cent affordable homes, but it will also bring Families and Homes services to those who need it most and we're one step closer to making that happen."

Eastfield House, consisting of new affordable homes at Central Parade, Walthamstow was officially opened by Cllr Grace Williams and Cllr Ahsan Khan, Deputy Leader and Cabinet Member for Housing and Regeneration on Thursday

The former run-down garage area behind the existing housing at Central Parade is now the site of Eastfield House, which consists of 21 affordable homes and includes a 167sam flexible commercial space that will be leased by the Council.

One of the first housing projects undertaken by Waltham Forest to complete this year, the scheme is 100 per cent affordable providing

11 homes for social rent and eight for shared ownership.

Former office space in the existing Central Parade building has also been converted into two new fourbedroom family homes for social rent.

Cllr Khan said: "I'm proud to

celebrate the completion of the Eastfield House project at Central Parade, the first completely affordable housing schemes Waltham Forest has completed this year. It's incredible that we've managed to turn a former garage site into much-needed new, highquality, affordable homes for

our residents right in the heart of Walthamstow.

"A project like Eastfield House shows how hard we're working to deliver on our plans to build more affordable homes and invest in opportunities that meet the needs of residents."

Training for residents looking for a career in theatre



Future Formed offers Waltham Forest residents the chance to find out about the creative industries and support them in finding paid work in the sector.

It aims to create opportunities

for groups who are underrepresented in the arts, or who may have had less access.

Future Formed recently collaborated with Jacksons Lane Theatre and Royal Opera House on a week-long Theatre

Technician training opportunity, with 11 people from Waltham Forest and neighbouring boroughs taking part.

Each placement is paid at London Living Wage, with the initial training offered for free

to make it accessible to as many people as possible.

Future Programme Project Lead Kaveh Rahnama explained: "From my own experience as a theatre maker and from additional conversations with

theatres, there is a huge lack of diversity in the sector, with a heavy percentage of technicians being both white and male.

"We did research into courses and could find none which offered both training and placements - especially paid placements - which would make opportunities accessible to those lacking the resources to be able to afford to take time out to work unpaid or to pay for a course.

"The programme has opened doors for a hugely diverse range of residents who have potential, but not necessarily the connections, to gain a foothold in an incredibly exciting but often hard to access career."

The Theatre Technicians course was so successful that another is being lined up later in the vear.

Special Objects: special memories

A fascinating window onto different lives and experiences of some of our newest residents

Visitors to the Adult Learning Service (ALS) based at The Junction, on the corner of **Cathall Road in Leytonstone** High Road, may have spotted something a bit different brightening up the walls and glass partitions on the first floor.

Stop for a minute to look at the exhibits in the Special Objects exhibition and you will see a snapshot of people's lives around the world before they arrived in Waltham Forest. Each entry describes an object that means something to the person writing, which they either brought with them on their travels or they found here to remind them of home.

The stories are written by ALS students who are keen to improve their reading and writing skills and form part of their English for Speakers of Other Languages (ESOL) course. The Special Objects are exhibited at both ALS centres and have appeared at Vestry House Museum. They are a fascinating window into different lives and experiences of some of our newest residents.

There is Zulaikha, originally from Pakistan, who writes about a necklace, a present from her parents on her seventh birthday, which reminds her of them. Kohinur, from Bangladesh, writes about a red saucepan that was bought for her by her father which she now uses to cook for her brothers when they visit.

Sara from Belgium writes about the teddy her aunt gave her when she was four and which still sleeps in her bed today. Florin describes the watch worn on special occasions that reminds him of his family in Romania, while Sonila keeps a special stone on display, which has travelled all the way to Waltham Forest from the mountains of Albania.





Future plans, fun and learning

Courses range from art, craft and gardening to business and digital skills and run during the day, in the evening and at weekends. At The Junction, you'll find computer


suites, pottery workshops, industrial sewing machines and sinks with mirrors for hairdressing classes.

The care goes on

Care leavers given protected characteristic status in Waltham Forest

Six young people growing up in the care system described how they faced discrimination and prejudice ahead of a vote by Waltham Forest councillors to offer care leavers more help on Thursday 27 April.

Under the policy, which was unanimously agreed, care leaver status will now be classed as a protected characteristic within the borough.

It will mean anyone with experience of the care system will be put on a par with other characteristics, such as age, sexual orientation, race, or disability when it comes to discrimination.

"I am really proud that **Waltham Forest and other** councils across London are taking this step"

Sandra Slaby, came into care at Waltham Forest when she was 15, following the death of her mother from leukaemia. She told the chamber: "At the time I was looking after my father. It was decided it was in my own interests to be put into foster

"I was very lucky, my foster mother was totally selfless and helped me readjust. I

really don't know what would have happened to me if I had been left on my own, it's difficult to imagine. Today I am at university, and I have a part time job. I'm backing this policy because it will help people understand the disadvantages we have from a very early age."

Also addressing the council were Terry Galloway, cofounder of the website Care Leaver Offer, and the government's national adviser for care leavers, Mark Riddell.

Terry Galloway said: "Around the country, the lives of care leavers are slowly improving as

more and more local authorities are making this vital change.

"I am really proud that Waltham Forest and other councils across London are taking this step, hopefully more will follow.

"As a care leaver myself, I've seen first-hand how so many lives struggle to recover from this early set back in life."


Describing the multiple disadvantages that care experienced young people and adults face, Councillor Alistair Strathern, the former Cabinet Member for Children and Young People, said more needed to be done.

He said: "It is a national shame that many of the most vulnerable who we take into care as a society face such significant challenges later in life.

"No parent would be happy with this, and as corporate parents we shouldn't be either.

"Righting the wrongs experienced by those let down by the care system is one of the equalities issues of our time."

Leyton dementia hub salon offers supports for sufferers and their carers

The salon, which opened as part of Dementia Action Week 2023, offers a free service available to those living with dementia and their carers.

The launch featured an Indian head massage demonstration and a pampering session for some of the service users.

Cllr Louise Mitchell, Cabinet Member for Adult Services at Waltham Forest Council, said: "I am so delighted that our ambition to create a 'sanctuary salon' has become a reality. I really hope that by adding the salon, we can provide not just a practical service, but a sense of some much-needed respite and relaxation, restoring that sense of self-worth and wellbeing. And not just for those living with dementia, but for their carers too."

Dr Turnbull, of the Waltham Forest Memory Service, shared some research into the benefits of Indian head massage for triggering memories in people living with dementia, before giving a demonstration.

"It made me feel peaceful and calm, I enjoyed it very much"

She said: "Massage can have a very positive effect on symptoms like agitation and depression in dementia. In a way, massage

is a form of communication. It's holding them in a safe space and making them feel valued."


Suriyah Rehman, who had the massage, said: "It made me feel peaceful and calm, I enjoyed it very much and would like to do it again."

The salon also offers pampering sessions, which can include haircuts, manicures, pedicures and hand massages. It is decorated with pictures of

Ensuring no one gets left behind

New campaign 'Let's Get Digital' helps residents get online and use their devices





Doreen is a local Waltham Forest resident, and five months ago she did not know how to use a computer or laptop.

After attending the Let's Get Digital drop-in sessions, she is now able to use her phone properly, learn to confidently type with her keyboard, and watch her favourite films and TV shows on her devices.

Doreen said, "It is amazing for me. I don't want to get left behind with computers and telephones. That's why I joined the drop-in sessions. I can order things on the computer and video call on my phone."

These drop-in sessions are part of the wider Let's Get Digital campaign that aims to ensure all residents can access the online world if they want to.

Each drop-in session will have dedicated, friendly volunteer Digital Champions who guide residents through whatever issue or query they may have related to their phone, laptop, tablet, or the internet.

Chris, a Digital Champion in Leytonstone, said: "I became a digital champion volunteer as I wanted to contribute and give back to my local community.

"The first person I helped had never touched a mouse or a computer before. She didn't know what the internet was and had never heard of Google. Through the sessions we broke down the mystique around getting online. Getting her to the point where she was confident filling out a form on a website was amazing."

There are still opportunities available to become a Digital Champion and make a difference to someone's life. As a volunteer, you receive training, and you don't need to be a digital expert. You just need a willingness to help people and a friendly attitude.

As well as the drop-in sessions across libraries in the borough, residents who receive Universal Credit and other benefits could also access cheaper broadband.

These social tariffs could save residents up to £200 a year on their internet bills.

Cabinet Member for Public Service, Cllr Paul Douglas, said: "We want to ensure every resident in the borough has the skills, tools, and support to get online. Getting online can mean greater access to jobs and education, staying in touch with our loved ones, booking doctor appointments and accessing all kinds of information and services."



Members Allowances

ELECTED MEMBERS (COUNCILLORS) OF AN AUTHORITY ARE ENTITLED UNDER THE MEMBERS' ALLOWANCES SCHEME TO RECEIVE REMUNERATION FOR THE DUTIES THEY PERFORM. THIS SCHEME IS SET OUT IN THE CONSTITUTION OF THE COUNCIL.

The scheme is governed by the Local Government & Housing Act, 1989, as amended and the Local Authorities (Members' Allowances) (England) Regulations, 2003.

All Councillors are entitled to a basic allowance to cover their democratic duties. Some Councillors also receive a Special Responsibility Allowance (SRA) reflecting the level of additional duties they undertake (see the table below).

Councillors who hold more than one post are only entitled to claim the SRA with the greatest value. In appropriate circumstances, Councillors can claim an allowance towards carers' costs, travelling and subsistence costs when carrying out certain duties outside the Borough.

The Council carries out a full review of its Councilors' Allowances Scheme, having regard to the London Councils' Independent Panel report, at the start of each 4-year electoral term, and confirms it annually. The current rates of allowances were agreed by the Council on 27th of April 2022

The following table sets out the current rates of Members' Allowances for the Municipal Year, May 2022 – May 2023. Also set out are payments made to individual Members in the financial year April 2022 – March 2023. These are prorated where members have been elected or stood down in May 2022, or where special responsibilities have changed.

- 2. The general effect of the Order would be, only at such times and to such extent as regulatory signs are displayed, to:
- (a) prohibit vehicles (except works vehicles) from entering, proceeding, waiting or loading for any purpose, at any time, in the following roads:
- i. Wyatts Lane E17
- ii. Prospect Hill E17
- II. Unuren Hill E17; and
- iv. Stainforth Road E17

(b) prohibit vehicles (except work vehicles) from waiting or loading for any purpose, at any time, in the following roads:

- i. Forest Road E17 between Winsbeach Road and Wood Street;
- ii. Wood Street E17 between Forest Road and Woodlands Road; and
- iii. Shernhall Street E17 between
- The Drive and Turner Road.
 3. Whilst works are being carried out and only at such times and to such extent as regulatory signs are displayed no person shall cause or permit any vehicle to proceed, wait, or load for any purpose, at any time, within 20 metres of the junction of any road adjoining the roads or sections of roads contained in paragraph **2(a)** above.
- 4. Whilst works are being carried out and only at such times and to such extent as regulatory signs are displayed no person shall cause or permit any vehicle to wait or load for any purpose, at any time, within 20

- metres of the junction of any road adjoining the roads or sections of roads contained in paragraph **2(b)** above.
- 5. Whilst the prohibitions referred to in paragraphs 2, 3 and 4 above remain in force, advance warning signage and alternative routes for traffic shall be in place.
- 6. Whilst works are being carried out and only at such times and to such extent as regulatory signs are displayed, any one-way working or no-entry prohibition in any road mentioned in paragraph 2(a), or in any roads adjoining the roads or sections of roads contained in paragraph 2(a), above will be suspended.
- 7. Designated controlled parking space situated in the roads or parts of roads affected by the measures set out in paragraph 2 above will be suspended.

 8. Vehicles waiting or loading in disregard of this Order would be
- removed.
 9. The prohibitions mentioned above would not apply in relation to any vehicle being used -
- (a) in connection with the said works;
- (b) for ambulance, fire brigade or police purposes (if the works allow) 10. The Order would come into operation on 24th July 2023 and would be valid for a maximum period of 18 months or until the works are completed, whichever is the sooner. NOTE: These works would not be carried out simultaneously in all roads but in a sequence as directed by the Council. Signage placed in advance of any works in the abovementioned roads which would give more specific details on the exact dates of the restrictions and effects of any temporary traffic management as necessary.


