Waltham Forest Local Plan Part 1 – Main Modifications Consultation Notice

Waltham Forest Council is preparing a new Local Plan. The Local Plan is in two parts. Part 1, the subject of this consultation notice, establishes the borough-wide spatial strategy and planning policies to guide development. Part 2 is a Site Allocations document. When adopted, the Local Plan will be used to manage growth and change in Waltham Forest over the next 15 years.

The Council has followed the statutory process for Local Plan production, including public consultation and engagement with stakeholders. Local Plan Part 1 was submitted for independent examination in April 2021. Following the conclusion of a second round of Examination in Public Hearings in March 2023, a schedule of Main Modifications to Local Plan Part 1 has been prepared for statutory consultation in accordance with the Town and Country Planning (Local Planning) (England) Regulations 2012. The Council is inviting representations on this schedule of main modifications and the following supporting documents:

- Post Hearing Main Modifications Sustainability Appraisal Report
- Post Hearing Main Modifications Habitats Regulations Assessment Addendum
- Proposed Changes to Submission Policies Map

For information, the Council is also publishing a schedule of additional modifications.

The main modifications are put forward without prejudice to the Inspectors' final conclusions.

The consultation period runs from Thursday 27th July to Thursday 21st September 2023.
