

## LONDON BOROUGH OF WALTHAM FOREST (T42(23))

### CHANGE FROM ADVISORY TO DESIGNATED DISABLED PERSONS PARKING PLACES AND AMENDMENT OF ADJACENT PARKING PLACES AND WAITING RESTRICTIONS AND NEW WAITING RESTRICTIONS (BATCH 15)

#### The Waltham Forest (Charged-For Parking Places) (Amendment No. -) Order 2023 The Waltham Forest (Free Parking Places, Loading Places and Waiting, Loading and Stopping Restrictions) (Amendment No. --) Order 2023

1. **NOTICE IS HEREBY GIVEN** that the Council of the London Borough of Waltham Forest propose to make the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.
2. The general effect of the Orders would be:
  - (a) to provide a designated disabled persons parking place measuring 6.6 metres in length (unless otherwise specified in Schedule 1 to this Notice) in each of the locations specified in Schedule 1 to this Notice, in most cases replacing advisory disabled persons parking places, on the carriageway, footway or both;
  - (b) where any proposed designated disabled persons parking place referred to in sub-paragraph (a) above is longer than the advisory disabled persons parking place it is replacing or where there is no existing advisory disabled persons parking place in the proposed location, to shorten or remove any existing parking place or waiting restriction in that location by the length necessary to provide the disabled persons parking place;
  - (c) to remove either advisory or formalised disabled person's parking place in each of the locations specified in Schedule 2 to this Notice and either extend existing or create new permit parking space; or in certain cases extend adjacent waiting restrictions bordering such disabled parking space by the length necessary in place of the disabled persons parking bay; and
  - (d) **Knebworth Avenue E17** - convert 2.6 metres of permit parking space into a no waiting at any time restriction outside Nos. 48 and 50.

[Note: If these proposals were to go ahead then it is intended that any proposal in a location referred to in this Notice that is within an experimental CPZ would not proceed until such time and under such circumstances as the provisions of the experimental Traffic Order for the CPZ in question were continued in force indefinitely by way of a permanent Traffic Order.]

3. A copy of each of the Orders, the Council's statement of reasons for proposing to make the Orders and plans showing the locations and effect of the Orders **can be inspected** until the end of a period of 6 weeks from the date on which the Orders are made, the Council decides not to make the Orders, on request by either emailing [traffic.scheme@walthamforest.gov.uk](mailto:traffic.scheme@walthamforest.gov.uk), or visiting (\*by appointment) the Highways, Low Hall, Argall Avenue E10 7AS during normal office hours on Mondays to Fridays inclusive; or alternatively documents can be viewed online at: [www.walthamforest.gov.uk/content/road-traffic-schemes-and-consultations](http://www.walthamforest.gov.uk/content/road-traffic-schemes-and-consultations).
