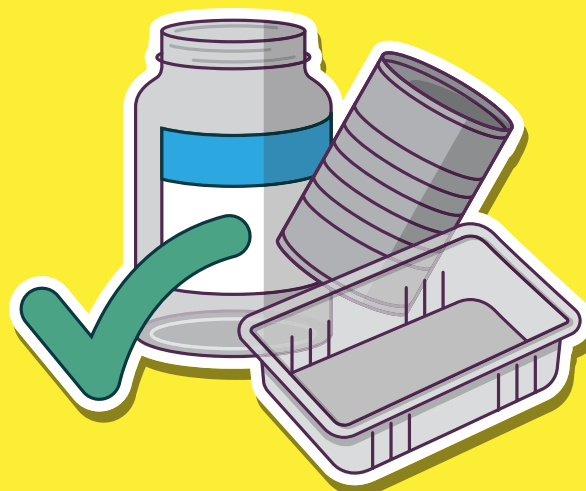

## No such thing as a free lunch?

Nearly 10,000 extra primary pupils across Waltham Forest started the new school year tucking into healthy, nutritious, and tasty free school meals for the first time this month.

To launch the year-long £135m capital-wide initiative London Mayor Sadiq Khan sat down with pupils, staff, and teachers, at Leyton's Newport Primary School for lunch.

They were joined by Waltham Forest leader Cllr Grace Williams and Cllr Kizzy Gardiner, Cabinet Member for Children and Young People.

Speaking in the dining hall of the Ofsted rated outstanding 770-pupil school, the Mayor said that offering all children a meal, regardless of income, would end stigma for the poorest pupils.

He added that the policy, the first of its kind to be launched on such a scale, "was making history" and would save hard-pressed parents around £440 a year per child.

Explaining why he had decided to make the offer universal, he said pupils had to attend school and needed to eat during that time. He said that no one would expect a hospital in-patient to have means tested food.

## Council Leader, Cllr Grace Williams



### Residents should be able to enjoy films on the big screen

**I have so many good memories of enjoying movies on the big screen at the Empire Cinema on Walthamstow High Street.**

Like many of you, I was very disappointed when the operator closed the cinema with no advance notice on Friday 7 July as it entered administration.

I was even more frustrated to learn about the unlicensed rave that took place in the building on Saturday 9 September. In partnership

with local police colleagues, council officers responded swiftly and effectively – by midday on Tuesday 12 September the squatters had left, we regained full possession of the premises from the former leaseholder and put our own security in place to keep it secure.

Keeping our residents safe is paramount and the actions of the squatters could have seriously endangered neighbours. I'd like to thank the police for their assistance.

We want to see the building return to use as a cinema as soon as possible so that we can all enjoy the magic of movies on the big screen in Waltham Forest.

Discussions with a range of cinema operators are underway. Protecting the existing building and its facilities will be key to making this happen. We'll release more information as soon as we can.

In other important news, a by-election will take place on

Thursday 26 October to elect a new councillor to represent Higham Hill ward following the resignation of Councillor Alistair Strathern.

Higham Hill ward includes postcodes starting E17 5-- or E17 6--, as well as N17 9NG. You can check what your ward is by visiting [bit.ly/WFWards](https://bit.ly/WFWards)

It's really important that everyone who is eligible to vote takes the chance to do so. If you are not going to be around on the day, you can vote by post – the deadline

to apply for a postal vote is Wednesday 11 October.

Please remember this is the first election in Waltham Forest where photo ID is required to vote after the Government changed the rules. You can find all the details about the by-election and what forms of ID are acceptable by visiting [bit.ly/HighamHill](https://bit.ly/HighamHill)

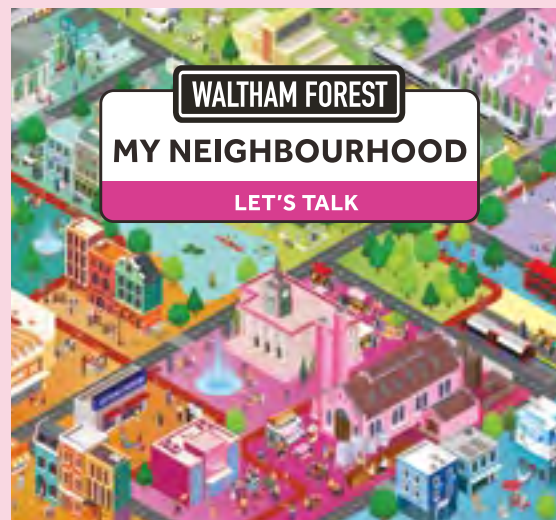

## The Pride of Waltham Forest awards are back for 2023

Bringing our communities together to celebrate our heroes

**These awards are an annual opportunity to shine a light on people in the borough who help to make Waltham Forest such a great place to live, visit and work.**

Whether it's a local business who give back to the community, someone who has been an environmental champion, a neighbour who looks out for the safety of their street – we want to hear about it through your nominations.

Last year, we received over 1000 nominations and this year we'd love to get even more. We have 11 awards categories, and you can nominate anyone who lives in Waltham Forest, or who runs their business here.

We were pleased to catch up with one of last year's winners – Jackie, current Chair of the Waltham Forest Women's Network (WFWN). In 2022 the WFWN won the 'Waltham Forest for All Award', for their work to improve the wellbeing of women in Waltham Forest of all age groups, ethnicities, and abilities.

**How did it feel when you knew you'd won a Pride of Waltham Forest Award?**

"It was amazing to find out that we'd won – it felt like recognition for the amount of work that had been done that year, and before that, during the pandemic – it was a lot.

We'd recently done things including hampers for homeless people, online yoga, and a big dinner and dance, in collaboration with Kiran Support Services, which was a chance for lots of women to come back after the pandemic and have an event to attend. Getting women back together was really important to us. So it felt amazing to be recognised for doing that."

**What was it like attending the Awards ceremony?**

"It was a really great night. We had eight of us there, including the woman who founded our network 18 years ago. The host was amazing, and it was nice to have that local connection with Soho Theatre.

It was also really inspiring, to see all of these different groups doing amazing things. I knew about some of them but not all of them, so it shows how many things there are happening

in the borough you might not know about. And it allows those groups to connect with each other as well."

**What would you say to someone thinking of nominating someone else for an award?**

"If you're thinking of nominating someone, I would say – go for it. There are so many people doing spectacular things in the borough, and I say we're all winners anyway. As long as someone gets nominated, they'll know they're being recognised for the work they've done, which is a great feeling."

**What's next for the WFWN?**

"We're marking Black History Month – we have an event in conjunction with our AGM at the end of October. We'll be continuing our women's health and menopause cafes, and we're waiting to hear about funding for some other women's health-related projects."

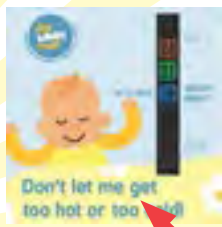

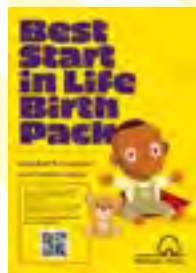

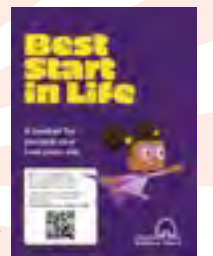

# Could you #BeTheOne and provide a loving home to a foster child?

New campaign launched to encourage residents to become foster carers

**#BeTheOne is Waltham Forest's new campaign to encourage residents to take the first step in fostering a young person in the borough.**

Fostering is caring for children in your own home who are unable to live with their own families. Fostering is open to anyone who has a spare room and is willing to open their homes and offer the support a child needs in their life.

*"It's been really good to see him grow and to turn into the young man that he's going to be"*

**Vince has been a foster carer for three years for his foster child. He said, "It's a lovely achievement to know we've given him a better quality of life."**

Vince was able to get a lot of support from fostering networks and previous foster carers. One of the most rewarding things for Vince was being able to provide completely new experiences for his foster child.

He said: "We got to take him on his first holiday, his first plane, and the first time he went to a beach."

"We've given him his firsts for a lot of things and that's been truly gifted back to us, to see how far he's come from when he arrived to where we are now. It's been really good to see him grow and to turn into the young man that he's going to be."

**As a foster carer you receive financial, social and emotional support throughout your journey:**

- Pay of up to £485 per week, per child
- Up to 66 per cent taken off your Council Tax bill if you live in Waltham Forest, or a payment towards it if you live out of the borough
- A free parking permit for your zone if you live in a CPZ
- Discounted membership at one of our six leisure centres in Waltham Forest for you and your family
- A dedicated social worker and out of hours support
- Support groups offering friendship and learning
- On-going support and training
- A virtual reality programme of support to increase your understanding of the needs of children

## Eman

**Eman's journey as a foster carer has seen her care for many children for over 17 years.**

She said: "I am proud that I am able to care for people and treat them with respect and make a difference in their life. I am also proud that I keep in contact with all the young people that I foster. Sometimes I receive Mother's Day cards, this means a lot."

Eman is a Hub Carer as part of the Council's Fostering Network Mockingbird programme. It is a network based on the idea of an extended family, to ensure young people and their foster carers receive even more care and support.

"I support ten families with their children. The main thing is relationship building with the other carers and their young people so that we can all support each other. We support each other like a family, helping with things like collecting a child from school. Mockingbird helps improve stability with young people and their carers."

Contrary to many misconceptions about foster carers, all types of people can foster, whether you are a single person, identify as LGBTQ+ or have a particular faith.

The Waltham Forest Fostering Team are looking for people from all different walks of life and do not discriminate against age, race, gender, or faith. Waltham Forest Council is a member of New Family Social, meaning LGBTQ+ people that apply to foster receive free access to support including forums and events.

## Shqiponja

**The process to becoming a foster carer can take four to six months, from the initial application form through to approval.**

All applicants go through a two-stage process to become an accredited foster carer.

There is also a particular need to foster children with disabilities and children who are migrants or refugees. Shqiponja has been a foster carer for five years and has looked after a young refugee from Afghanistan.

She said: "My foster son escaped from the Taliban and had a six-month journey to come here. I am very proud of him. He has connected well with people and has made a lot of friends and is very independent."

"He is going to university next week. He is moving on and I will miss him, but I am happy for him."

Shqiponja has an encouraging message for those that want to become foster carers but may be hesitant to take the first step.

She said: "Do not to be scared, sometimes people tell me they would be scared to foster. Treat the child like your birth children. It is rewarding and if they don't appreciate you straight away, they will appreciate you later on in life and remember you. They will come to appreciate you."

# RESIDENT VOICES SPARK ACTION

At the start of summer 2023, Waltham Forest Council asked residents to share practical ideas on how they would improve their neighbourhood with £10,000. 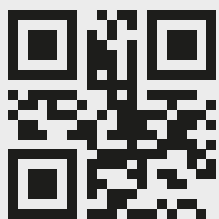

# GET YOUR AUTUMN BOOSTER

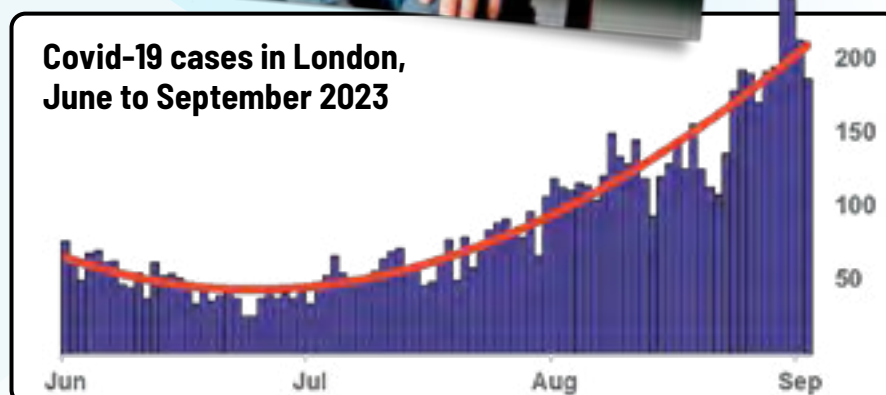
The autumn dose of the Covid-19 vaccine is now available in pharmacies and health centres.

**Covid-19 cases are rising in Waltham Forest.** In August, a new strain of the virus (Pirola, or BA.2.86) was found in the UK, making it especially important that you **get your free booster** if eligible.

The autumn booster vaccine is **the single most effective way** to protect people over 65 and clinically vulnerable people from severe illness and hospitalisation if they catch Covid-19 this winter.

Having the booster also makes it less likely that you will catch Covid-19 at all.

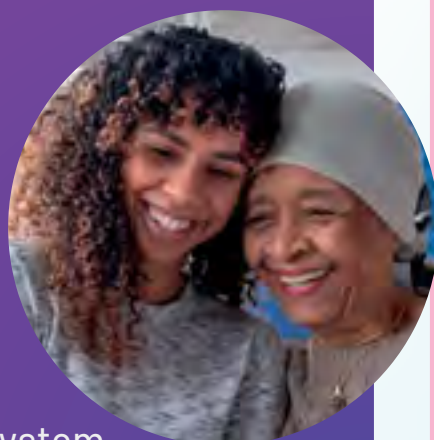
*Don't forget: most people eligible for a Covid jab are also eligible for a free flu jab, which can be booked through your GP.*



## WHO CAN GET THE AUTUMN DOSE?

You may be offered a seasonal Covid-19 vaccine if you are:

- aged 65 or over
- clinically vulnerable
- a frontline health or social care worker
- a carer
- living in a care home for older adults
- living with someone with a weak immune system



## HOW TO GET THE AUTUMN DOSE:

If you're eligible, you can get an autumn dose of the Covid-19 vaccine by:

- booking online
- booking on the NHS App
- Calling 119 if you can't book online

He said: "This will make a big difference for families struggling to make ends meet during the cost-of-living crisis.

"Having received free school meals myself as a child, I know how important a healthy and nutritious lunch can be, and it's great to see such an inspiring, imaginative and tasty menu on offer at Newport School."

Mr Khan added it would be closely monitored over the next year to see the effect the policy was having on attendance, attainment, concentration, and behaviour.

Until this month free school meals in London were only provided to all children up to Year 2.

After that, only children from households receiving certain benefits received a free meal.

For households on universal credit, they must earn less than £7,400 a year - after tax and not including benefits, and regardless of the number of children in the family - for their children to be eligible for the meals.

The additional meals for primary pupils aged between seven and 11 are being funded by £130m from business rates and £5m from City Hall reserves.

The Mayor's free school meals programme will also help complement Waltham Forest's own Breakfast for Learning initiative, where £600,000 is being spent from the Household Support Fund to support primary

aged children who have been identified as needing breakfasts before school.

Welcoming the new free school meals, Cllr Williams said: "It's a truly shocking fact that one in four children in Waltham Forest

are living on poverty as their families struggle to pay their bills.

"As a former teacher, I know from experience the negative effect that going to school hungry has on children's health and educational outcomes."

Dishes on offer included smoky jackfruit jambalaya, tomato and basil pasta, and homemade cheese and onion puffs. They are among 50 dishes provided every fortnight for 46 schools across the borough by award-winning Waltham Forest Catering.

# Helping our armed forces community

**The Mayor of Waltham Forest Cllr Roy Berg is fundraising to support those whose served and kept us safe**

**Cllr Roy Berg served in the Royal Air Force for 34 years and supporting the armed forces community is one of his priorities during his year as Mayor of Waltham Forest.**

We spoke with Alistair Martin, veterans coordinator at Age UK Waltham Forest, about his work: "I'm tasked with combatting loneliness amongst veterans in the community.

We run a series of regular social groups and occasionally we run day trips for our members.

"In April, Waltham Forest Council helped fund a day trip for veterans to the secret nuclear bunker at Kelvedon Hatch. Underneath what appears to be a country cottage in the middle of a forest is a facility housing the apparatus to re-establish civil government in the aftermath of a nuclear strike. All of us on the trip had

lived through the Cold War so the prospect of an afternoon reminiscing was tantalising.

"Age UK Waltham Forest organises four regular veteran events each month. There's the breakfast club on the first Saturday of the month from 9am at the Greene Man pub in Chingford, E4 6RB. There are two coffee clubs at the Age UK hub at 58 Hall Lane, Chingford, E4 8EU at 2pm on the second and

fourth Mondays. Then on the last Wednesday we host a lunch club at Leyton Orient Football Club from midday, just come to the club reception to join.

"If you are a veteran, a war widow, or have any association with the armed forces you'll be made very welcome. You'll make some new muckers and maybe join us on one of our future days out."

## Official launch of UoP London

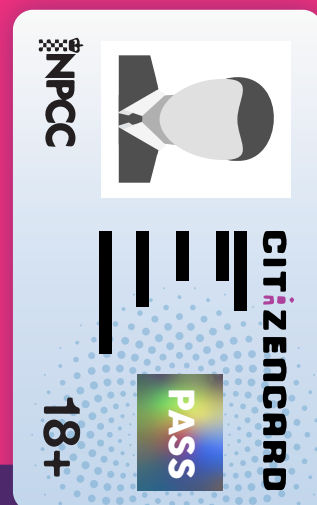
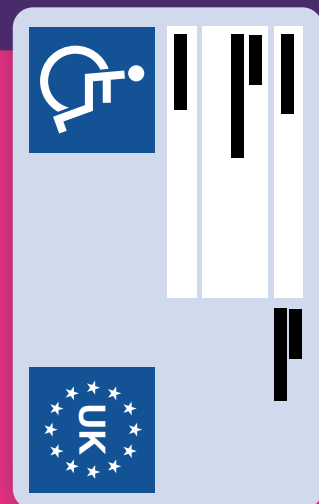
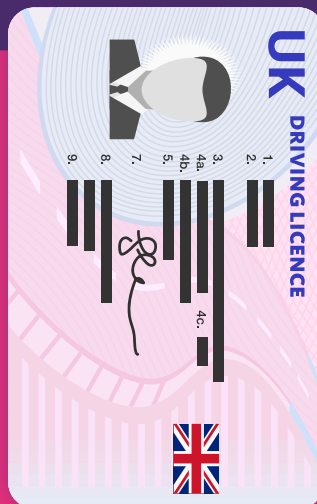

Upon arrival, the children eagerly gathered by the pool. With the help of the staff, the children

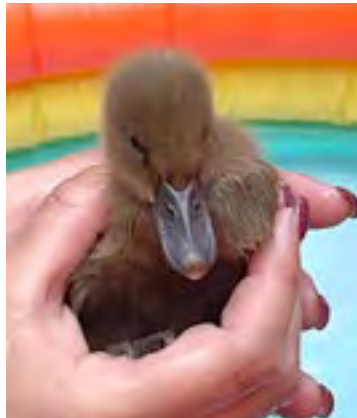
took turns to carefully cradle the baby ducks in their hands, while the garden filled with the sounds of their young chirping.

# Paying it forward

From supported to supporter

**Akila was at a difficult point of her life when she first met Donna, a Council Link Worker. Two years later, Akila is volunteering for Early Help, the service which once supported her.**

Akila said: “When I saw Donna again while volunteering a few weeks ago, I just started crying. I hugged her and said: “You got me out of my home. You are an angel. You showed me a world is there for me still.

“I first met her in 2021. I was bedbound with a health condition, and I’d stay indoors for days. I was very isolated.

“I was referred to the Council’s Adult Early Help Link Worker team and was supported by Donna. She came to my house regularly.

“First, she would help with my finances, or help me fill out forms. She slowly started taking me out of the house, going for coffee, taking breaks when I needed.

“After another period of severe illness, I thought, I have to do something, I have to live my life. I came to Walthamstow Family Hub and started volunteering for the Community Drop-Ins. That’s where I saw Donna for the first time in a year.

“When I help people, it makes me more confident. I know more than anyone that when you’re struggling, you feel stuck, so I love to support people. It’s just amazing that I can do it with the same service who’d helped me before.

“With the confidence I have, I’ve now started an English language course at the Adult Learning Centre, and soon I’m going to start an accountancy course too!”

**This autumn, we’re encouraging everyone to be on the lookout for hedgehogs in places such as gardens, hedgerows, woodlands, grasslands, parks, and cemeteries, as part of our ‘Action for Nature’ programme of activities, events and surveys.**

A familiar species to most, hedgehogs are nevertheless in trouble, with the UK population declining by a shocking 50 per cent since 2010.

Here in Waltham Forest, we want to protect them long into the future. That’s why we are running a campaign to raise awareness and gather information about our local hedgehogs. We’re grateful to local people who have already got in touch with vital intelligence about our local hedgehog population.

Sally from Chingford said: “I was delighted when I first noticed a hedgehog in the garden a few years ago - since then I’ve been putting out food in a home-made feeding box. The same one or two hedgehogs come most nights, and on one occasion there were three.”

Another resident Jacqui, added: “We are happy to report that we saw a hedgehog in our front

garden over the summer and have also been seeing female stag beetles which is brilliant too.”

Councillor Clyde Loakes, Deputy Leader and Cabinet Member for Climate, said: “We want to learn much more about our hedgehogs so I want to say a huge thank you to everyone who has contacted us to report sightings so far.

“The decline in this species is saddening but our Climate Action Plan is in place to protect a multitude of species, including hedgehogs and support green spaces and enhance our biodiversity.

“There are also plenty of ways you can help hedgehogs in your garden. Creating small holes in your fence, planting hedges, checking long grass and piles of leaves before cutting and avoiding slug pellets are just a few small ways you can make a big difference.”

Local resident Jacks added: “Providing a water source for our local hedgehogs is vital, as many of the ones that are found are severely dehydrated, access to water is much more restricted with habitat loss.”

## Top tips to help hedgehogs in your garden:

- **Make your garden pond hedgehog-safe by adding a ramp or slope**
- **Check for hedgehogs before lighting any bonfires**
- **Cut out pesticides and slug pellets when managing your garden**
- **Put out food and water if hedgehogs are visiting**
- **Create gaps and holes in the bottom of your fence so hedgehogs can move in and out**

# Community service

Earlier this year **Saira Begum Mir BEM, BCAC**, was awarded the **Freedom of the Borough** by Waltham Forest Council for her charity work

**“We’re not just a food bank, you know,” says Saira Begum Mir before reeling off a bewildering list of services her charity PL84U Al-Suffa offers Waltham Forest most needy residents.**

Indeed, temporarily based in Leytonstone the charity has at various points arranged everything from a fortnightly Sunday lunchtime meal club to haircuts for the homeless, to providing white goods and decorating services for rehoused victims of domestic abuse.

And it doesn’t stop there. As well as running the three-times weekly foodbank, she and her army of around 50 volunteers have just introduced mini-food banks around the borough (working similar to the mini-libraries that have sprung up in people’s front gardens in recent years – created by Sean Rodrigo) and are in the final stages of a new shop.

It’s little wonder that this uncompromising human dynamo is attracting a lot of attention – most recently as the latest beneficiary of the Freedom of the Borough from Waltham Forest Council. She is also a recipient of the British

Empire Medal and British Citizenship Award Medal of Honour amongst many others.

Beneath her softly spoken Yorkshire accent (her parents moved the family to Bradford from Uganda shortly before Idi Amin came to power) lies a steely determination that dares to dream up these ideas and, crucially, put them into action.

In 1985 she moved south to get married and settled in Waltham Forest with her husband. She found work as an outreach worker, a role which made her realise the “shocking” extent of homelessness and social isolation especially for the older generations in an adopted country.

“I wanted to do something that would be about bringing communities together,” she explains. “I didn’t just want to do something for an ethnic minority group or one age group, I wanted people of all ethnicities and all age groups

and social backgrounds to get together under one roof.”

It was while volunteering at Faizan-e-Islam Mosque, she learned of the Near Neighbours Network, a Church of England initiative to bring together people of different faith and ethnic backgrounds in the cities.

Having agreed to fund the idea she was able to get more assistance from Muslim Aid, who were looking for a UK project to back. She was aided by her husband Farooq and their three children.

That there was a need for the service was obvious when on the first day when more than 30 people turned up.

She said: “I had done my market research and found that there weren’t any services for people on a Sunday, so that’s the day we held it.

“The idea was that we would all eat together, it’s a way of showing that the food we were providing is good for you, is good for us. And when you sit together and eat together, that’s when people will talk.

“Homeless people would tell us what they needed, haircuts, razor blades and slowly our services expanded organically

to fit the needs of the people.”

All that changed during Covid-19 when lockdowns made the weekly get-togethers impossible. So, with help from the Council she changed her model to become a food bank, offering walk-in, referral and delivery services: “Our council has been very supportive,

especially so when you hear about other boroughs.”

Today, she estimates that the charity helps out around over 500 people a week with groceries, providing store cupboard basics as well as fruit and vegetables.

So, what next? With the shop opening soon, you can bet it won’t be long before this restless social campaigner who describes herself as a “proud immigrant” is dreaming up something new.

## Drop litter, pick up a fine

### Action taken against litter louts

**A landowner who ignored repeated demands to clear up his Leyton property has been hit with a £3,700 fine.**

Mohammad Sadiq, the freeholder of the land at Station Parade, Leyton High Road, was served an abatement notice on January 25 this year.

Despite being warned by Waltham Forest Council's Neighbourhoods Team more than five times between January and April to clear the yard, nothing was done.

In the meantime, the rubbish – which included hundreds of black bin bags and two mattresses – continued to build up.

At Thames Magistrates' Court on Tuesday 29 August, he was found guilty in his absence of four counts of failure to comply with an abatement notice under Section 80 of the Environmental Protection Act 1990.

Sadiq, of Byron Avenue, South Woodford, was fined £400 for each offence plus an £800 victim surcharge and £905 in costs.

Waltham Forest Council has cleared up the mess and will now be chasing payment from the landowner.

His fine follows a crackdown on Waltham Forest litter louts which saw nine people fined a total of more than £5,000 for

dropping rubbish or spitting on the borough's streets.

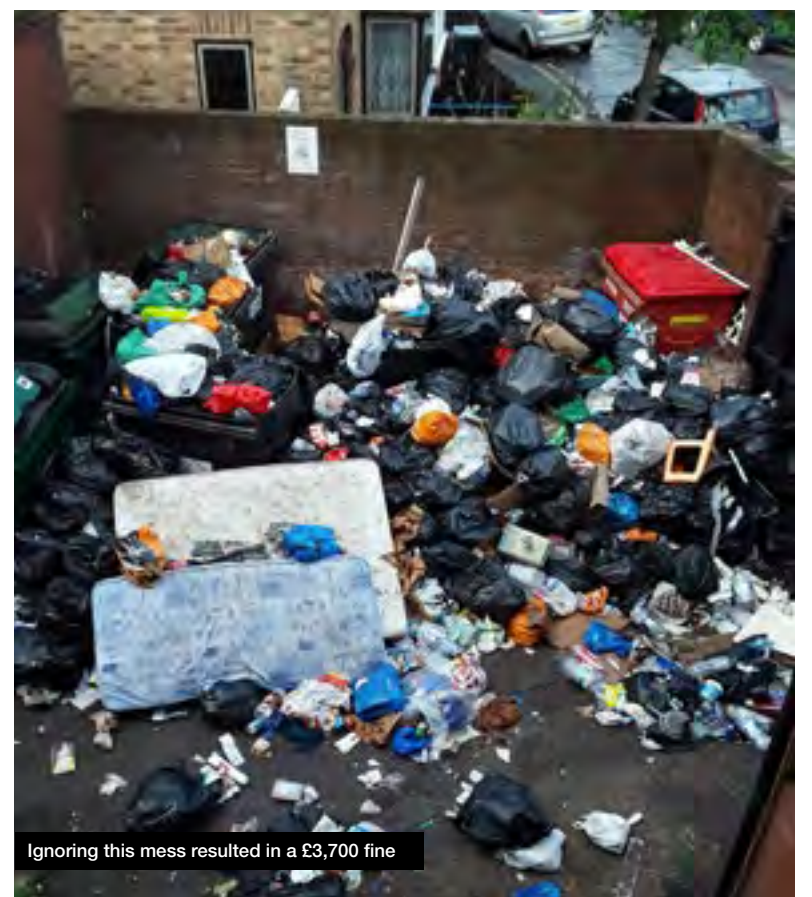
All the offenders aged between 18 and 64 were seen, and handed their original fixed penalties, over the space of a week in February this year.

When they failed to pay their cases were heard at Thames Magistrates' Court on August 21.

Each offender was fined £220, ordered to pay an £88 victim surcharge, and £300 costs.

Find out more about the Waltham Forest Film Office – and how your home could end up the star of the show

**Ever spotted a BAFTA Award-winner in a night-time car chase through Chingford Mount? Or walked down Orford Road in Walthamstow Village and found yourself in Whitstable on the Kent Coast? If so, there's every chance that the Waltham Forest Film Office has had something to do with it.**

Our Film Office manages location shoots in Waltham Forest which provide community benefits borough wide – not just in the areas where filming takes place.

Its work brings together the film industry, local community and voluntary sectors to provide training and development, including work placement and employment opportunities for local residents who want to gain experience and pursue a career in the industry.

It also helps local charities and students on their productions.

Areas that accommodate filming benefit from the presence of production crews – including through increased use of cafes, restaurants and shops, or by paying for local accommodation and parking. Industry research has shown every £1 spent directly to the local authority for a permit to film results in an average £1.54 spent in the local area where that filming takes place. And for areas of high-level filming, the office obtains voluntary donations which fund and support community work, groups and support.

Here are some examples of productions that have been filmed in the borough over the years. And yes, that really WAS Bonners fish and chip shop in Northcote Road, Walthamstow, with a starring role in this year's Eurovision Song Contest trailer!

# Police partnership leads to local improvements

## Working together for Safe Streets

**In March the Council launched a new initiative called Safe Streets in partnership with the Metropolitan Police, piloted in South Leytonstone and Chingford Mount.**

Safe Streets aims to bring together different services for a joint problem-solving approach, making it easier for residents to report concerns and engage with the Council and police officers working locally.

Top priorities for each area were identified based on feedback from residents and local councillors.

A hyper local problem-solving approach involving partners was developed to tackle each issue with significant levels of success throughout.

### Chingford Mount: ATM distraction thefts

There were a spate of ATM distraction thefts in Chingford Mount at the beginning of 2023, often targeting older and more vulnerable residents.

The Safe Streets team adopted a problem-solving approach and implemented preventive measures including stencilling privacy boxes outside premises and providing crime prevention advice to staff at banks/building societies.

As a result there were only two ATM thefts in the pilot areas between March and May 2023, compared to six in the three months leading up to February 2023, equivalent to a 66 per cent reduction.

### South Leytonstone: Operation Melius

A key concern for residents of South Leytonstone is the illegal activity associated with some local garage businesses, including illegal parking and unsafe waste disposal practices.

Starting in April, regular spot checks have been conducted by multi-agency teams from the police, Council and fire service. Enforcement is carried out against vehicles being repaired on the public highway, parking infractions, environmental and safety risks, untaxed vehicles and misuse of blue badges.

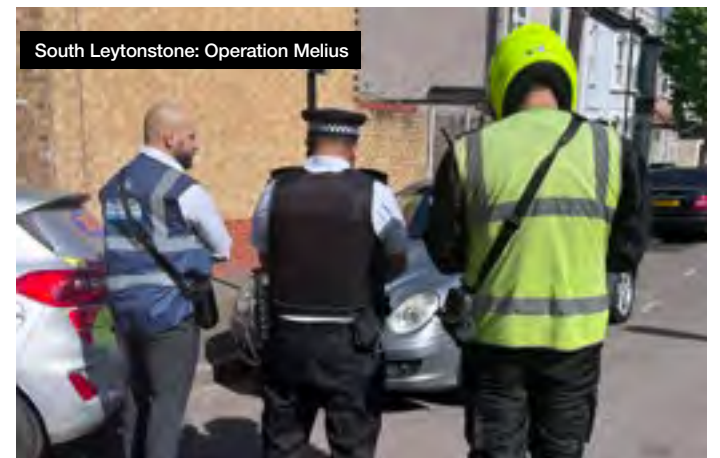
Clear improvements have been noted, with fewer infractions identified on each visit and businesses fully aware of their responsibilities.

# How are we helping residents at risk of homelessness

## A local response to the national housing crisis

**Due to the cost-of-living crisis, lack of affordable private rented sector accommodation in London and many households being impacted by the government's benefit cap, homelessness is becoming more prevalent in these challenging times.**

We are developing a local response to the national housing crisis. In July, Cabinet approved proposals around "Reshaping our Homelessness Support Offer". This report emphasised a focus and investment to tackle the key issues causing homelessness and outlined earlier preventative measures.

It covered three initiatives: firstly, a return of homelessness face-to-face appointments; secondly, our new Housing Sustainment Team; and, finally, a new housing advice offer for residents in the private rented sector.

- Return of face-to-face appointments – since the pandemic all homeless assessments have taken place online or over the phone. Although this approach provided several benefits, Cabinet agreed that face-to-face appointments are important for residents in immediate crisis or with accessibility issues. This service will run on an appointment only basis and there will be NO walk-in or self-referrals.

- Our new Housing Sustainment Team will identify and work with households at risk of homelessness before they reach a point of crisis. The team's focus will be on families within the private rented sector, particularly those who are impacted by the government's benefit cap. The team will provide advice and assistance across a wide range of issues including benefits, employment, and health that enables them to sustain their tenancies'. The new team will work closely with other council departments to identify and reach out to those most in need.

we work to help them find a suitable solution in settled accommodation. We appreciate how stressful the situation can be for anyone in this position. Local demand for housing is increasing, and the supply of affordable properties is limited.

We know the only way out of the housing crisis is to build more family homes for social rent and while we have one of the best records for delivering

more of these properties, we know there is more to be done.

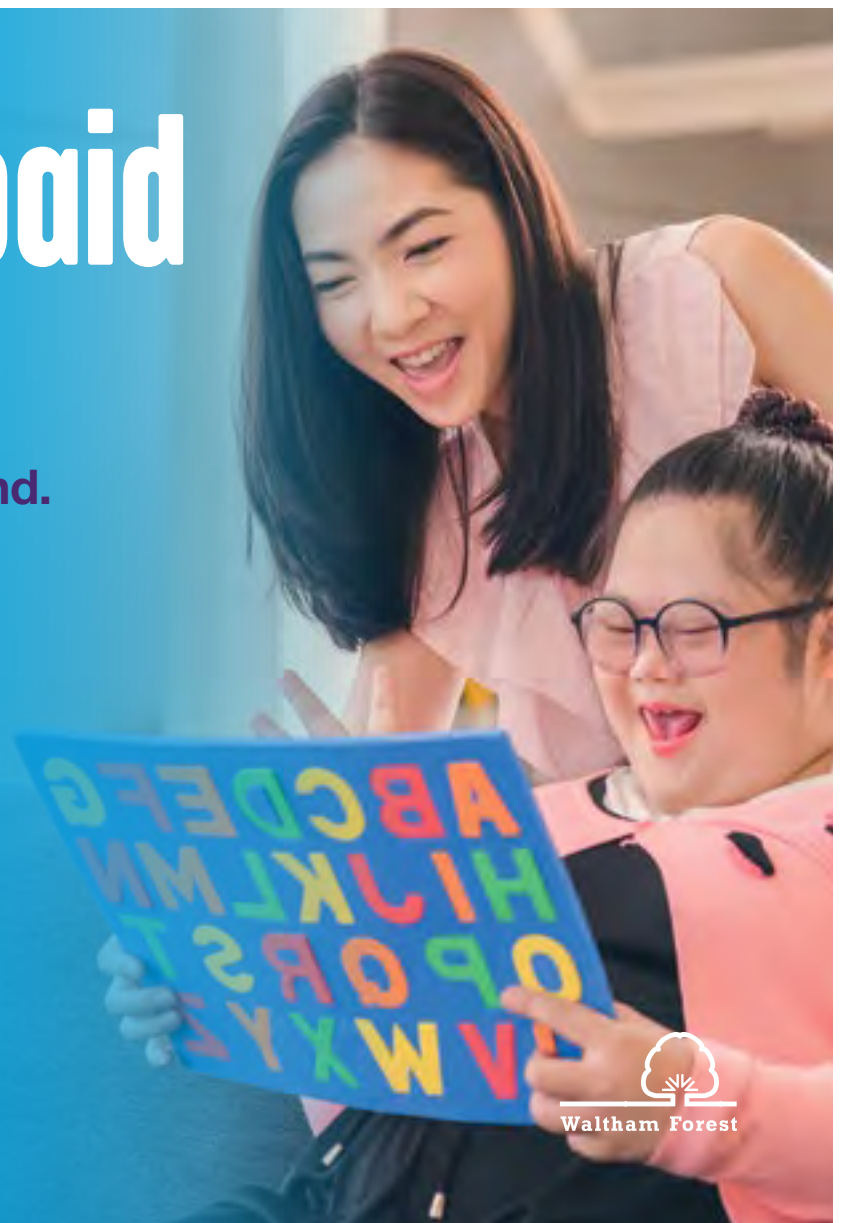

The 'pedestrian and cycle zone' extension will operate between 8.30 a.m. and 9.30 a.m. and between 2.45 p.m. and 3.45 p.m. on Monday to Friday inclusive - although in practice it is anticipated that they will only operate during these hours in school term-time, when the traffic signs are showing.

a. All motor vehicles except permit holders, will be prohibited from entering the pedestrian and cycle zone during their hours of operation. Permits allowing vehicles to enter the pedestrian and cycle zone will be available to residents of and employees of businesses and organisations at premises located within or only accessible from the pedestrian and cycle zone, and to disabled person's badge holders who have a bona fide reason to enter or leave a vehicle in the pedestrian and cycle zone, by application to the Council. Any vehicle that is already within the pedestrian and cycle zone prior to its commencement of operation will be permitted to leave. Further exemptions will apply to: Emergency service vehicles; Council Waste Services; other key Council services (e.g. Social Services); Mobility Services vehicles; and Public service vehicles (e.g. Community Transport, Dial-a-Ride).

b. The extension is intended to create a pleasant environment that feels safer in the immediate vicinity of a school, discourage travelling to school by car in cases where alternative means of travel are available, and encourage walking, scooting and cycling to school, thereby achieving positive health outcomes for the school community. (b) in **Ardleigh Road (ARD)**  
a. to close to vehicular traffic (including motorcycles) (except pedal cycles) the full width of the \*\*highway opposite between the northern kerb line of Ardleigh Terrace northwards for 10 metres (all vehicular traffic will be prohibited from proceeding or entering) and provide double yellow line "at any time" waiting restrictions on both sides of closure perpendicular to the kerb lines; and  
b. **west side** – suspend permit parking space outside Nos. 23 to 27 ARD by 10 metres.  
(c) in **Blenheim Road (BLE)** prohibit vehicular traffic (including motorcycles) (except pedal cycles) entering Blenheim Road at its junction with Blackhorse Lane. All motor vehicles would be prohibited from entering into or proceeding past this point at all times.  
(d) prevent motor vehicles entering **Brettenham Road** (section east of point 2 metres west of the eastern flank wall of No. 29) where entry to that section of road is prohibited by a no-entry sign plate situated 2 metres west of the eastern flank wall of No. 29.

(e) prevent motor vehicles entering **Elphinstone Road** where entry to that road is prohibited by a no-entry sign plate situated at its junction with Winns Avenue.

(f) prevent motor vehicles entering **Fleeming Road** where entry to that road is prohibited by a no-entry sign plate situated at its junction with Pennant Terrace.

(g) in **Keith Road (KEI)**  
a. prohibit motor vehicles (except cyclists) from proceeding at any time in any direction other than from south-east to north-west; and  
b. prevent motor vehicles entering Keith Road where entry to that road is prohibited by no-entry sign plate situated at its junction with North Countess Road.

(h) in **Monoux Grove (MON)** to close to vehicular traffic (including motorcycles) (except pedal cycles) the full width of the \*\*highway between its junction with Billet Road southwards for 3.5 metres (all vehicular traffic will be prohibited from proceeding or entering) and provide double yellow line "at any time" waiting restrictions on both sides of the closure perpendicular to the kerb lines (north side is Billet Road junction).

(i) in **Pennant Terrace (PEN)**  
a. to close to vehicular traffic (including motorcycles) (except pedal cycles) the full width of the \*\*highway between the eastern kerb line of the Thorpe Crescent (its western arm) and the western kerb line of Elphinstone Road its width being 3.5 metres (all vehicular traffic will be prohibited from proceeding or entering) and provide double yellow line "at any time" waiting restrictions on both sides of the closure perpendicular to the kerb lines;  
b. to close to vehicular traffic (including motorcycles) (except pedal cycles) the full width of the \*\*highway between the western kerb line of Rushbrook Crescent and the eastern kerb line of Carr Road its length being 3.5 metres (all vehicular traffic will be prohibited from proceeding or entering) and provide double yellow line "at any time" waiting restrictions on both sides of the closure perpendicular to the kerb lines;  
c. prohibit motor vehicles (except cyclists) from proceeding at any time in any direction other than from west to east between its junctions with North Countess Road and the east kerb line of Thorpe Crescent;

d. prohibit motor vehicles (except cyclists) from proceeding at any time in any direction other than from east to west between the eastern kerb line of Fleeming Close (its west arm) and the eastern kerb line of Elphinstone Road;  
e. prohibit motor vehicles (except cyclists) from proceeding at any time in any direction other than from east to west between the eastern kerb line of Rushbrook Crescent and the eastern kerb line of Fleeming Close (its eastern arm); and  
f. prevent motor vehicles entering

**Pennant Terrace** (section immediately east of the easternmost kerb line of Fleeming Close) where entry to that section of road is prohibited by a no-entry sign plate situated at its junction with Fleeming Close (easternmost arm).

(j) in **Rushbrook Crescent (RSB)** prohibit motor vehicles (except cyclists) from proceeding at any time in any direction other than from north to south between its junctions with Penrhyn Avenue and Brettenham Road.

(k) in **Tavistock Road (TAV)** prohibit vehicular traffic (including motorcycles) (except pedal cycles) entering Tavistock Road at its junction with Blackhorse Lane. All motor vehicles would be prohibited from entering into or proceeding past this point at all times.

(l) in **Thorpe Crescent (THP)**  
a. to close to vehicular traffic (including motorcycles) (except pedal cycles) the full width of the \*\*highway between its junction with Keith Road eastwards for 3.5 metres in length (all vehicular traffic will be prohibited from proceeding or entering) and provide double yellow line "at any time" waiting restrictions on both sides of the closure perpendicular to the kerb lines;  
b. prohibit motor vehicles (except cyclists) from proceeding at any time in any direction other than from south to north and then generally in a north-westerly prion; and  
c. south side - suspend 7.5 metres of permit parking space outside Nos. 38 to 40.

(m) in **Winns Avenue (WIN)** to close to vehicular traffic (including motorcycles) (except pedal cycles) the full width of the \*\*highway between the eastern kerb line of South Countess Road its length being 16.5 metres (all vehicular traffic will be prohibited from proceeding or entering) and provide double yellow line "at any time" waiting restrictions on both sides of the closure perpendicular to the kerb lines;  
**\*\*Note: the designation of all closures to vehicular traffic (modal filters) mentioned in item 2 above will operate across the full width of the highway boundary including the footways/pavements.**

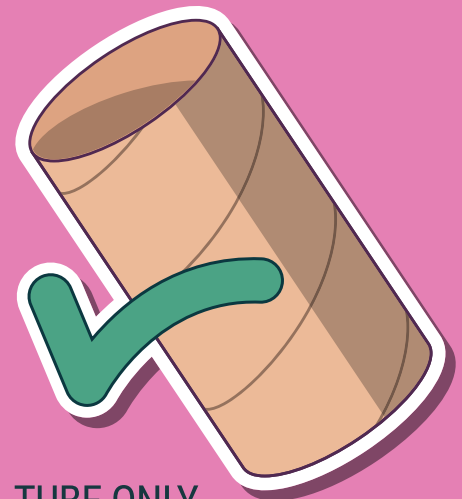
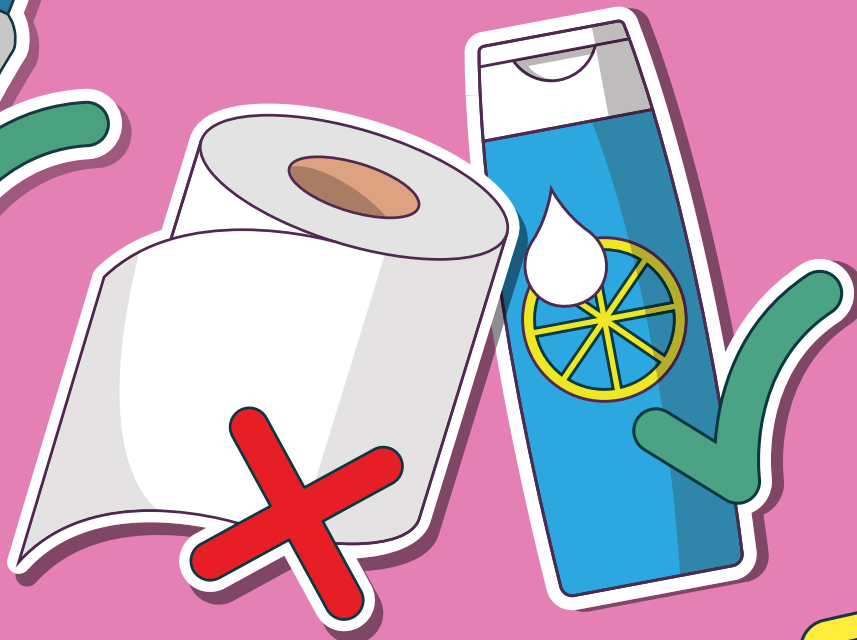

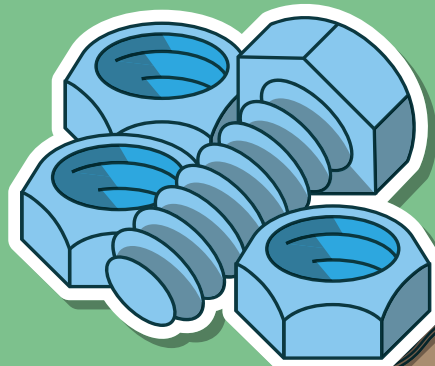
