The Council of the London Borough of Waltham Forest, after consulting the Commissioner of Police of the Metropolis, in exercise of powers conferred by section 84 of the Road Traffic Regulation Act 1984(a), as amended and of all other powers thereunto enabling, hereby make the following Order:

- 1. This Order shall come into operation on x x 2023 and may be cited as the Waltham Forest (20 m.p.h.) (Hall Lane E4 (north/south)) (No. x) Speed Limit Order 2023.
- 2. No person shall cause or permit any vehicle to exceed a speed of 20 miles per hour in **Hall Lane E4** (north to south arm) between its junction with Hall Lane (west to east arm) and a point 3 metres north of the common boundary of Nos. 303 and 305 Hall Lane.
- 3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those regulations.
- 4. So far as any provision imposed by this Order conflicts or is inconsistent with any provision of any Order made under the Road Traffic Regulation Act 1984, as amended, the provisions of this Order shall prevail.

- 1. This Order shall come into operation on x x 2023 and may be cited as the Waltham Forest (20 m.p.h.) (Chingford Mount Road/Chingford Road E4) (No. x) Speed Limit Order 2023.
- 2. No person shall cause or permit any vehicle to exceed a speed of 20 miles per hour in:
  - (a) Chingford Mount Road E4 between the common boundary of Nos. 266 and 268 Chingford Mount Road E4 and its junction with Chingford Road E4
  - (b) **Chingford Road E4** between its junction with Chingford Mount Road E4 and Nos. 40 and 42 Chingford Road E4
- 3. No speed limit imposed by this Order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011(**b**) when used in accordance with regulation 3(5) of those regulations.
- 4. So far as any provision imposed by this Order conflicts or is inconsistent with any provision of any Order made under the Road Traffic Regulation Act 1984, as amended, the provisions of this Order shall prevail.
