### Introduction

- Section 88P of the School Standards and Framework Act 1998 (the Act) requires every local authority to make an annual report to the adjudicator. The Chief Adjudicator then includes a summary of these reports in her annual report to the Secretary of State for Education. The School Admissions Code (the Code) sets out the requirements for reports by local authorities in paragraph 6. Paragraph 3.30 specifies what must be included as a minimum in the report to the adjudicator and makes provision for the local authority to include any other matters. Paragraphs 6 and 3.30 of the Code require that each local authority publish its report locally.
- 2. This year's report must cover the 2022/2023 academic year and be submitted to the Office of the Schools Adjudicator (OSA) by 31 October 2023.
- 3. Please note that, in response to feedback on the draft template, changes have been made to section 2C of this template.
- 4. Please also note that the OSA and Department for Education are planning a small project to ensure that the report is as useful as possible to local authorities, the OSA, DfE and others. As a result of this, there are likely to be changes made to the template for the 2023/2024 academic year.

#### Guidance on completing the template

- 5. We have included all the guidance on completing specific parts of the template in this section. There is no requirement for local authorities to include the introduction and the guidance in their published reports, but they are free to do so if they wish.
- 6. We should be grateful if in completing questions which ask for information about primary and secondary schools and/or pupils, local authorities would follow the approach to classification of schools used in statutory provisions and in the Department for Education Statistical First Release<sup>1</sup> and the Education Middle School (England) Regulations 2002<sup>2</sup>.
- 7. Guidance on specific questions and/or meaning of specific terms in this report:
  - a. "in-year admissions": This means admissions (that is children admitted to a school and not applications for places):
    - i. at the start of any school year to a year group which is not a normal point of entry for the school concerned (for example at the beginning of Year 2 for a five to eleven primary school); and

Corruption in one of the iteration files uploaded for Year 7 to PAN London. Impacted approx. 20-30 children who were applying across boroughs, however this was remedied in the C&D reports provided to other boroughs. Mitigations to reduce risks of this occurring again are now in place.

In addition to the work with care experienced children, the borough has also developed our social and medical criteria to include children with social workers to support the expanded duties for the Virtual School to oversee the educational outcomes for these children.

If a child is on SEN Support they would need to apply through the general admissions process. This includes any child who has just started the process of undergoing a statutory assessment as there is no guarantee at this stage that they will meet guidance for an EHC Plan.

We continue to see high levels of children with additional needs at SEND Support and with EHCPs. The local area continues to mature in its response to the pressure.

In local authorities where the majority of schools are academies and/or their own admissions authority, In-year admissions for CLA can be protracted. Direction processes are slow and can result in children in care being without a school place whilst a direction is requested from the SoS. There is also a lack of consistency as to the application of Fair Access Protocols with CLA from LA to LA.

Over the past academic year, there seems to have been an increase in the number of out of borough schools either reluctant or refusing to admit CLA on the grounds that they already have a large number of CLA on roll.

In both examples above, places were obtained through extensive negation between the VSH and the school headteacher; however, this takes time and results in CLA being out of school for an unacceptable amount of time.
