RE: Newham and Waltham Forest Low Traffic Neighbourhood Scheme – Area 2

As part of the Low Traffic Neighbourhood (LTN) currently underway in partnership with the London Borough of Newham, Waltham Forest Council is introducing 'modal filters' at five locations in South Leytonstone (Blenheim Road, Odessa Road, Ramsay Road, Thorpe Road and Hesketh Road).

Modal filters involve installing planters or signs at specific locations to stop motorised vehicles from travelling through while still allowing access for walking and cycling. The modal filter being installed on Odessa Road will be enforced by CCTV and there will be a gap between the planters to allow access for emergency vehicles only. All other motorised vehicles will not be allowed to travel through these modal filters and will be issued with a Penalty Charge Notice (PCN) if they do.

These works are part of the temporary scheme for the area, which aims to create people friendly streets with less traffic, noise and pollution, that are safe and more pleasant to use. Throughout the scheme we are asking the local community to feedback on the changes before developing a permanent scheme. The views of local people are vital to the success of the scheme, therefore please take a moment to find out more about the project and share your thoughts by visiting our online map-based survey at newhamwalthamforestltn.commonplace.is

Further to the recent project leaflet delivered to local residents on 5 August 2020 we are now writing to inform you that construction works to install modal filters in Area 1 are currently underway, and works in Area 2 on the streets which sit within Newham will start this week. Construction of the modal filters in the Waltham Forest section of Area 2, listed above, will start on Tuesday 1 September and will take approximately 1 to 2 weeks to complete.

To allow us to carry out the work safely and on time, we ask that you avoid parking in the works areas. There will be barriers, signs and traffic cones that show where parking is prohibited, and illegally parked vehicles will receive Penalty Charge Notices (PCN) and may be removed.

You can find contact details for the council's parking enforcement contractors and details of their changes overleaf, should you need them.
