Nomination papers must be delivered to the Constituency Returning Officer at the London Borough of Waltham Forest, Walthamstow Assembly Hall, Waltham Forest Town Hall, Fellowship Square, Forest Road, Walthamstow, London E17 4JF between the hours of 10.00am and 4.00pm on any week day after and including the date of this notice, but by **no later than 4.00pm on Wednesday, 27th March 2024**.
4. The £1,000 deposit required can be paid by legal tender (cash), by means of a banker's draft from a drawer which carries on business as a banker in the United Kingdom or by electronic transfer of funds.

Money laundering rules will apply if the deposit is paid in cash, and you will be required to provide proof of the source of the monies paid.

11. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work or service reasons must reach the relevant authority's Electoral Registration Officer (see 5 above) **by 5.00pm on Thursday, 2nd May 2024**. Any such physical incapacity must have occurred **after 5.00pm on Wednesday, 24th April 2024**. To apply on the grounds of work or service, the person must have become aware that they are not able to attend their polling station in person **after 5.00pm on Wednesday, 24th April 2024**.
