Jack's Farm (JF) Permit Parking Review We're proposing changes to parking on your road




Dear Resident, Business or Occupier,

The Jack's Farm (JF) Restricted Parking Zone (RPZ) currently operates in Jack's Farm Way and Celebration Way from Monday to Saturday, 9am to 5pm. These hours were established when the RPZ was initially introduced in 2014. A review of the existing parking zone is being carried out in response to requests received from residents to extend the timings due to insufficient parking availability outside the operational hours.

We want you to tell us what you think about the operational days or hours, and if there are any other adjustments that could be made to improve parking in your area. The proposed operational days and hours are reflective of the recent residents' requests.

A map of the area under review is shown below.



Local people know their neighbourhood best and we're asking everyone living or working in your neighbourhood to tell us what they think about these changes. The decision on whether the current CPZ operational days and hours will be changed will be made wholly based on the results of this consultation.
