

# Vernon Road Permit Parking Consultation

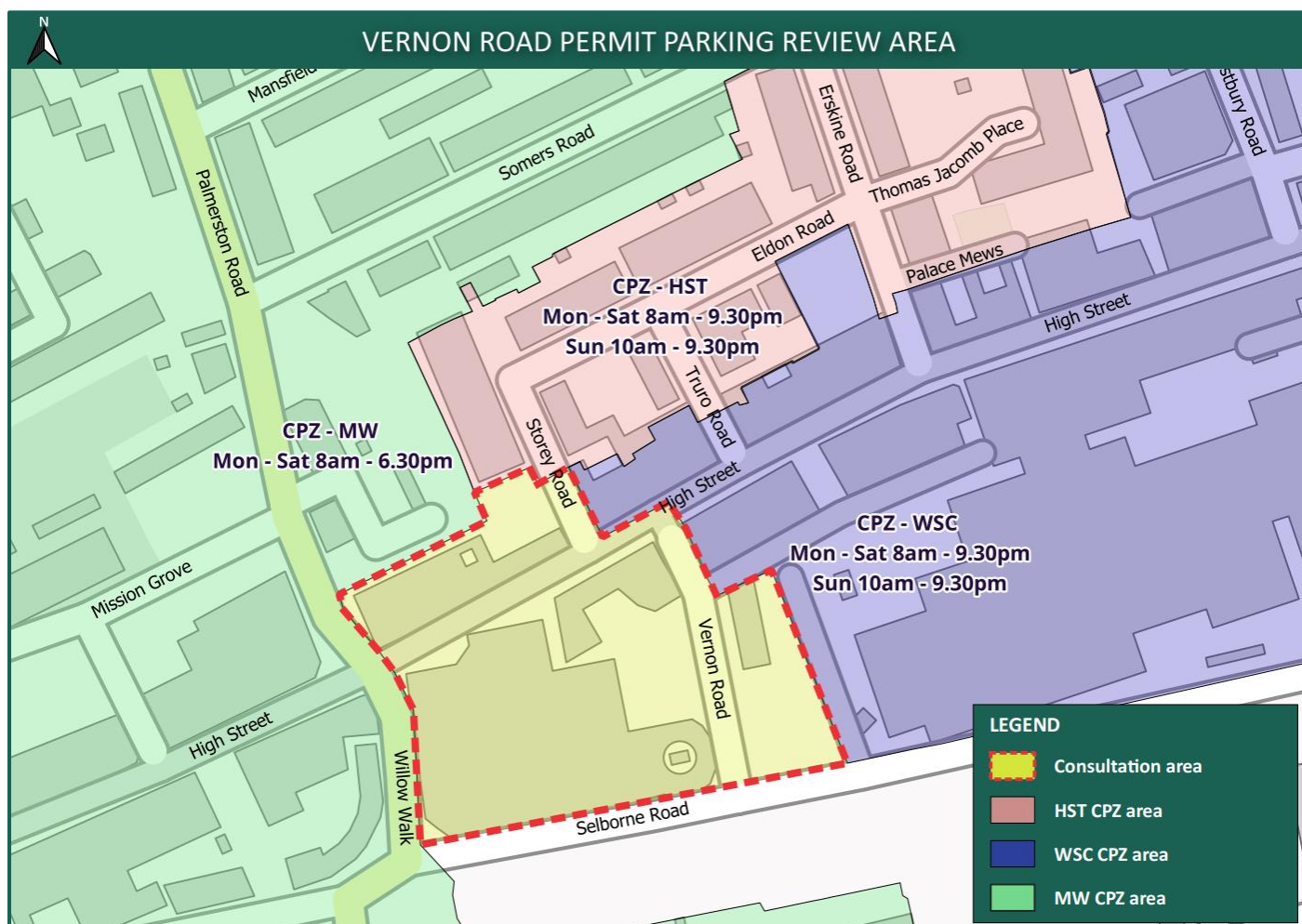
## We're proposing changes to parking on your road

Dear Resident, Business or Occupier,

The Council would like your feedback on how permit parking is working for you. Vernon Road is currently part of the Walthamstow Central (WSC) Controlled Parking Zone (CPZ) which was introduced in 2020 following a review of CPZs in the area. In response to requests from residents and local ward Councillors, we are proposing that properties within Vernon Road, and the section of High Street between Willow Walk and Storey Road are incorporated into the High Street (HST) CPZ. This proposal is being put forward to facilitate parking for residents and businesses located in the area.

The HST CPZ operates from Monday to Saturday, 8am to 9.30pm, and Sunday, 10am to 9.30pm. If the majority of respondents to this consultation are in favour of changing to the HST CPZ, the times of operation for your road will remain unchanged. You will then be able to park within any road within the HST CPZ area and you will no longer have access to permits for the WSC CPZ.

A map of the area under review is shown below.



Local people know their neighbourhood best and we're asking everyone living or working in your neighbourhood to tell us what they think about these changes. The decision on whether the boundary will be changed will be made wholly based on the results of this consultation.
